

ANNUAL APPROPRIATION BILL OF THE
CITY OF URBANA, ILLINOIS, FOR STREET AND BRIDGE PURPOSES
IN THE TOWN OF CUNNINGHAM, CHAMPAIGN COUNTY, ILLINOIS

FOR THE YEAR BEGINNING MAY 1, 1954, AND ENDING APRIL 30, 1955.

WHEREAS, the City of Urbana, Illinois includes wholly within its corporate limits, the Town of Cunningham, and, therefore, comes within the provisions of Section 69-6 of Chapter 24 of the Revised Statutes of the State of Illinois, for the levying of a street and bridge tax.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That for the fiscal year commencing May 1, 1954 and ending April 30, 1955, there be and is hereby appropriated for street and bridge purposes in the Town of Cunningham, Champaign County, Illinois, the sum of \$16,300.00, pursuant to the provisions of Section 69-6 of Chapter 24 of the Revised Statutes of the State of Illinois.

SECTION 2. That, whereas, three-fourths of the members elected to the City Council of the City of Urbana are of the opinion that a greater levy for bridge and street purposes is needed, there is hereby appropriated for said fiscal year, an additional sum for street and bridge purposes in the amount of \$9,700.00, pursuant to the provisions of Section 69-6 of Chapter 24 of the Revised Statutes of the State of Illinois.


That the total appropriation of \$26,000.00, be and is in addition to all other tax to be levied by the City of Urbana for general corporate purposes as provided in Section 16-1 of Chapter 24 of the Revised Statute of the State of Illinois, and in addition to (1) any tax that said City is now authorized to levy for street and bridge purposes and in addition to (2) any tax that said City is now authorized to levy on all property within the City, and shall be expended as follows:

Street signs	\$2,000.00
Painting light standards, curbs and street signs	2,000.00
Removing snow - sidewalks and streets	2,000.00
Cutting weeds in streets and alleys	1,000.00
Trimming trees in streets	1,000.00
Repairing and relaying sidewalks	5,000.00
Repairing streets - labor	5,000.00
Material for street repairs	5,000.00
Repairing sewers and manholes	3,000.00

	\$26,000.00

SECTION 3. That this ordinance shall take effect and be in force ten days after its passage, approval and publication as required by law.
