

AN ORDINANCE REPEALING SECTION 11.23 OF THE  
CODE OF THE CITY OF URBANA, ILLINOIS OF 1954

WHEREAS, Section 11.23 of the Code of the City of Urbana, Illinois of 1954 was included in said Code by mistake when said Code was edited in 1954.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

That Section 11.23 of the Code of the City of Urbana, Illinois of 1954 is hereby repealed and the following Section 11.23 substituted therefor.

Sec. 11.23. Fee From Foreign Fire Insurance Companies.

Every corporation, company and association which is not incorporated under the laws of the State of Illinois and which is engaged in effecting fire insurance in the City of Urbana, Illinois, shall pay to the Treasurer of the City of Urbana for the maintenance, use and benefit of the Fire Department, the sum of two per cent (2%) of the gross receipts received from fire insurance upon property within the City. The Fire Department shall, at an annual meeting to be held during the first week of May of each year, elect officers of the Department, including a Treasurer, and adopt rules and regulations concerning the use of the money collected from the foreign fire insurance companies. The City Treasurer shall pay the sums received from the insurance companies to the Treasurer of the Fire Department, and the Treasurer of the Fire Department shall pay out said money only upon the order of the Fire Department for the maintenance, use and benefit of the Department. The Treasurer of the Fire Department shall give a sufficient bond to be approved by the Mayor conditioned upon his faithful performance of his duties under the rules and regulations of the Department and under this ordinance, and the State Law authorizing same.

That Section 11.23 of the Code of the City of Urbana, Illinois of 1954 is hereby repealed and the following Section 11.23 substituted therefor.

Section 11. 23. Fee From Foreign Fire Insurance Companies.

Every corporation, company and association which is not incorporated under the laws of the State of Illinois and which is engaged in effecting fire insurance in the City of Urbana, Illinois, shall pay to the Treasurer of the City of Urbana for the maintenance, use and benefit of the Fire Department, the sum of two per cent (2%) of the gross receipts received from fire insurance upon property within the City. The Fire Department shall, at an annual meeting to be held during the first week of May of each year, elect officers of the Department, including a Treasurer, and adopt rules and regulations concerning the use of the money collected from the foreign fire insurance companies. The City Treasurer shall pay the sums received from the insurance companies to the Treasurer of the Fire Department, and the Treasurer of the Fire Department shall pay out said money only upon the order of the Fire Department for the maintenance, use and benefit of the Department. The Treasurer of the Fire Department shall give a sufficient bond to be approved by the Mayor conditioned upon his faithful performance of his duties under the rules and regulations of the Department and under this ordinance, and the State Law authorizing same.
