AN ORDINANCE AMENDING THE ANNUAL APPROPRIATION ORDINANCE OF THE
CITY OF URBANA, ILLINOIS, FOR THE YEAR BEGINNING MAY 1, 1954
AND ENDING APRIL 30, 1955

WHEREAS, the City Council of the City of Urbana, Illinois did on the 19th day of July, A. D. 1954 adopt an ordinance entitled "Annual Appropriation Bill of the City of Urbana, Illinois for the Year Beginning May 1, 1954 and Ending April 30, 1955"; and

WHEREAS, said ordinance provided in Section 15 thereof as follows:

SECTION 15. Nothing herein shall be construed as prohibiting the redistribution of the funds herein appropriated, so that the amount herein appropriated for any express purpose which shall later be found to be in excess of the amount actually needed for such purpose, may be allotted and added to the amount herein appropriated for some other express purpose which shall later be found to be less than the amount needed for such purpose; nor shall the same be construed so as to prohibit the addition of any amounts from revenue which may be received hereafter, which are not at this time anticipated or foreseen; nor shall anything herein be construed to prohibit the right to make such redistribution and allotment of the funds herein appropriated when the same have been found to be greater than or less than the amounts actually needed for the purpose for which such amounts were appropriated," and

WHEREAS, it appears that insufficient amounts were appropriated for certain purposes hereinafter mentioned and that excess funds were appropriated for certain other funds hereinafter mentioned so that it is possible to redistribute such excess amounts to the purpose for which insufficient funds were appropriated; and

WHEREAS, pursuant to law certain new funds were created during the fiscal year to provide for Off-Street Parking within the City of Urbana, making it necessary to provide appropriations for expenditures to be made from said funds;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That the Annual Appropriation Bill of the City of Urbana, Illinois for the Year Beginning May 1, 1954 and Ending April 30, 1955, is hereby amended as follows:

\$2,000.00 of the amount appropriated for the current expenses of the Building and Grounds Department in Paragraph 4 of said Ordinance is hereby redistributed and reappropriated for the Contigent Fund for contingent purposes.

\$1,000.00 of the funds appropriated for the Light Department in Paragraph 6 of said Ordinance are hereby redistributed and reappropriated for the purpose of purchasing compensation insurance.


SECTION 2. There is hereby appropriated for the current expenses of the operation of the Motor Vehicle Parking System Facilities of said City from the Motor Vehicle Revenue Fund, the following:

For parking meters	\$2,000.00
For appraisals	50.00
For engineering services	500.00
For advertising and printing	400.00

SECTION 3. There is hereby appropriated from the Motor Vehicle Off-Street Parking Construction Fund, the following:
