AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the City Clerk of the City of Urbana, Illinois on the 1st day of August, A. D. 1955, requesting the annexation of the territory hereinafter described, which said petition was signed under oath by David F. Hubbard, and Howard O. Watson, the owners of all of said real estate in said territory in which there are no electors residing; and

WHEREAS, more than two-thirds of the aldermen are of the opinion that it would be for the best interests of the people of the City of Urbana. Illinois that said territory be annexed to, and made a part of the city limits of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That the territory described as follows, to-wit:

Commencing at a point on the East line of the Southeast Quarter of the Northeast Quarter of Section 20, Township 19 North, Range 9 East of the 3rd Principal Meridian, said point being South 00 29* East, with reference to the true meridian, a distance of 443.00 feet from the Northeast Corner of said Southeast Quarter of the Northeast Quarter of Section 20, aforesaid, thence South 0° 29° East a distance of 585.00 feet, thence South 89° 38° West a distance of 563.63 feet, thence South 49° 59° West a distance of 376.28 feet, thence South 68° 25° West a distance of 120.51 feet, thence South 0° 38° East 12.00feet to the quarter section line, thence South 890 31* West a distance of 177.00 feet, thence North 00 38* West a distance of 424.91 feet, thence North 49° 59° East a distance of 195.41 feet, thence South 40° 01° East a distance of 60 feet, thence North 49° 59° East a distance of 130.53 feet, thence North 0° 38* West a distance of 33.73 feet, thence North 89° 38° East a distance of 175.00 feet, thence North 0° 38° West a distance of 100.00 feet, thence North 89° 38° East a distance of 115.00 feet, thence North 0° 38° West a distance of 125 feet, thence North 89° 38° East a distance of 380.48 feet, thence North $0^{\rm 0}$ $29^{\rm *}$ West a distance of 35 feet, thence North 89° 38° East a distance of 185 feet to the point of beginning, containing 13.9 acres, more or less, all as shown on the attached plat, and situated in Champaign County, Illinois,

excepting from the above described tract of land that portion of the West 175 feet of the Southeast Quarter of the

Northeast Quarter of said Section 20, lying within the above described tract of land, said exception having heretofore been annexed to the City of Urbana, Illinois, with other lands.

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana. Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territory within the corporate limits of said City.

SECTION 2. The City Clerk of the City of Urbana, Illinois, shall record with the Recorder of Deeds of the County of Champaign, Illinois, a copy of this ordinance, together with an accurate map of the annexed territory.
