AN ORDINANCE FOR THE ANNEXATION OF TERRITORY

\*\*\*\*\*

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the County Clerk of Champaign County on the 5th day of August, 1955, requesting the annexation of the territory herein described to the City of Urbana, and requesting the Judge of the County Court of Champaign County to submit the question of the annexation of said territory to the corporate authorities of said City, said territory being described in said petition as follows:

Commencing at the intersection of the South line of Oregon Street and the East line of Glover Avenue in the City of Urbana, County of Champaign and State of Illinois, thence South along an extension of the East line of Glover Avenue to the Northeast line of the Wabash Railroad Company right-of-way, thence in a Southwesterly direction across said Railroad right-of-way and across the Philo Road to the East point of Lot Fifty-eight (58) of Martha C. Hubbard's Second Addition, thence West along the South line of Lot Fifty-eight (58) of Martha C. Hubbard's Second Addition to the East line of Cottage Grove Avenue, thence North along the East line of Cottage Grove Avenue to a point One Hundred Five feet (105') North of the center line of Washington Street, thence East to a point directly South of the Southeast corner of Lot Sixty-six (66) of Martha C. Hubbard's Second Addition, thence North along the East lines of Lot Sixty-six (66) and Sixty-three (63) of Martha C. Hubbard's Second Addition to the South line of Oregon Street, thence East along the South line of Oregon Street to the point of beginning, all situated in the County of Champaign and State of Illinois,

And it further appearing to the City Council that a hearing was had in the County Court on said petition, and that proper notices were given according to law of said hearing by publication in the Champaign-Urbana Courier, and that pursuant to said hearing the Judge of said County Court entered an order directing the question of the annexation of said territory be submitted to the corporate authorities of the City of Urbana, Illinois, and

WHEREAS, the City Council of said City finds that a certified copy of the order of the County Court entered on the 26th day of August, 1955, was sent to the City Clerk of the City of Urbana, Illinois, and that said order finds that all the necessary legal steps were taken by the petitioners for the annexation of said territory to the City of Urbana; that said order finds that the petition requesting said annexation was

signed by a majority of the owners of record of land in said described territory; that said certified copy of the order was received by the City Clerk of the City of Urbana from the Clerk of the County Court of Champaign County on the 6th day of September, 1955, and

WHEREAS, it appears to the City Council that there were no objections filed in the County Court to the annexation of said territory to the City of Urbana:

IT IS, THEREFORE, the opinion of more than two thirds of the duly elected aldermen of said City that it would be to the best interest of the territory described in said petition, and for the best interest of the landowners and electors of said territory, and for the best interest of the entire City of Urbana that said territory be annexed to and become a part of the City of Urbana.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That the territory described as: -

Commencing at the intersection of the South line of Oregon Street and the East line of Glover Avenue in the City of Urbana, County of Champaign and State of Illinois, thence South along an extension of the East line of Glover Avenue to the Northeast line of the Wabash Railroad Company right-of-way, thence in a Southwesterly direction across said Railroad right-of-way and across the Philo Road to the East point of Lot Fifty-eight (58) of Martha C. Hubbard's Second Addition, thence West along the South line of Lot Fifty-eight (58) of Martha C. Hubbard's Second Addition to the East line of Cottage Grove Avenue, thence North along the East line of Cottage Grove Avenue to a point One Hundred Five feet (105') North of the center line of Washington Street, thence East to a point directly South of the Southeast corner of Lot Sixty-six (66) of Martha C. Hubbard's Second Addition, thence North along the East lines of Lot Sixty-six (66) and Sixty-three (63) of Martha C. Hubbard's Second Addition to the South line of Oregon Street, thence East along the South line of Oregon Street to the point of beginning, all situated in the County of Champaign and State of Illinois,

be and the same is hereby annexed to and shall become a part of the City of Urbana, Illinois, and that the corporate limits of said City be and the same shall be changed so as to include said territory within the corporate limits of said City.

SECTION 2. This ordinance shall be in full force and effect on the expiration of thirty days from the date of this ordinance unless a

referendum thereon shall be subsequently ordered by said City Council or unless a petition for such referendum shall be filed with the City Clerk of said City. In case of such a referendum, this ordinance shall be of full force and effect if a majority of the electors voting upon the question favor the annexation of such territory to the City of Urbana. If a majority of the electors voting upon the question vote against such annexation, then this ordinance shall become null and void.
