N.E. BY E. LINE OF WABASH R.R. 5556-22

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO
THE CITY OF URBANA, ILLINOIS

WHEREAS, it is provided in Article 7-11 of the Cities and Villages Act of the State of Illinois that whenever any unincorporated territory containing sixty (60) acres or less, is wholly bounded by a municipality, such territory may then be annexed to said municipality by the passage of an ordinance to that effect, and

WHEREAS, the hereinafter described territory is wholly bounded by the City of Urbana, a municipality located in the County of Champaign and State of Illinois,


THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

1. That the following described territory, to-wit:

Commencing at the intersection of the West line of Lot Sixty-five (65) of Martha C. Hubbard's Second Addition and the Northeast right-of-way line of the Wabash Railroad Company in the City of Urbana, County of Champaign and State of Illinois, thence in a Southeasterly direction along the Northeast right-of-way line of said Wabash Railroad Company right-of-way to the South point of Lot Sixty-six (66) of Martha C. Hubbard's Second Addition, thence South to a point One Hundred Five feet (105') North of the center line of Washington Street extended, thence West to the East line of Cottage Grove Avenue, thence North along the East line of Cottage Grove Avenue to the point of beginning, all situated in the County of Champaign and State of Illinois,


