AN ORDINANCE EXPRESSING THE DESIRE OF THE CITY COUNCIL OF
URBANA TO ANNEX CERTAIN TERRITORY TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it is provided in Section 7-2 of Chapter 24 of the Cities and Villages Act of the State of Illinois that the corporate authorities of any municipality may initiate a proceeding for the annexation of territory by enacting an ordinance expressing their desire to annex such territory, and

WHEREAS, it is further provided that such ordinance, if enacted, shall request the judge of the county court of the county in which said city is located to submit the question of the annexation to the corporate authorities of the annexing municipality, and

WHEREAS, the corporate authorities of the City of Urbana desire to initiate the annexation to said city of the territory hereinafter described;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That the corporate authorities of the City of Urbana, Illinois desire to annex to said city, the following described territory, to-wit:


Commencing at a point Three Hundred Thirty feet (330') East of the Southwest corner of the Northwest Quarter of Section Nine (9) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian in Champaign County, Illinois, thence West along the North boundary line of the City of Urbana and along the South line of the Northwest Quarter of said Section Nine (9) and along the South line of the Northeast Quarter of Section Eight (8) to the East line of the Champaign County Housing Authority Land, then North along the East line of said Housing Authority Land to the Northeast corner thereof, thence West along the North boundary of said Housing Authority Land to a point directly South of the East line of Division Street, thence North to the center line of Kerr Avenue, thence East along the center line of Kerr Avenue to a point Twenty feet (20') South of the Southeast corner of Lot Eleven (11) of Orville J. Hewkin's Subdivision, thence North along the East line of Orville J. Hewkin's Subdivision to a point Thirty feet (30') North of the Northeast corner of Lot One (1) of said Orville J. Hewkin's Subdivision, thence West to the East line of Division Street, thence North to the North line of Oakland Avenue, thence West along the North line of Oakland Avenue to the East line of Broadway, thence North along the East line of Broadway

Avenue to the North line of Section Eight (8), thence East along the North line of Section Eight (8) and the North line of Section Nine (9) to the Northeast corner of Lot Three (3) of a subdivision of the West Half of the Northwest Quarter of said Section Nine (9), thence South along the East line of said Lot Three (3) to the Southeast corner of said Lot, thence West Three Hundred Thirty feet (330'), thence South to the place of beginning, all situated in the County of Champaign and State of Illinois,


which said territory is contiguous to the City of Urbana, Illinois and which area is not included within the boundaries of any other municipal corporation.

SECTION 2. That the City Attorney of the City of Urbana, Illinois be authorized and directed to petition the County Judge of the County of Champaign, Illinois to submit the question of the annexation of such territory to the City of Urbana, Illinois in accordance with the provisions of Article 7-2 of the Cities and Villages Act of the State of Illinois.
