AN ORDINANCE AMENDING CHAPTER 21 OF THE CODE OF THE CITY  
OF URBANA, ILLINOIS OF 1954

---

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

That the following Sections 21.49 through Section 21.53 be added to Chapter 21 of the Code of the City of Urbana, Illinois of 1954:

Sec. 21.49. Minors under 14 years not permitted on streets after certain hours.

It shall be unlawful for any minor under the age of 14 years to be on any street, alley or any of the public places in the City of Urbana, Illinois after the hour of 10:30 P.M. A minor who is accompanied by one of his parents, guardian or other adult persons responsible for his care and custody is excepted from this prohibition.

Sec. 21.50. Minors Between the Ages of 14 and 18 Years Not Permitted on Streets After Certain Hours.

It shall be unlawful for any minor between the ages of 14 and 17 inclusive, to be on any street, alley or any other public place in the City of Urbana, Illinois, after the hour of 11:00 P.M. on Sundays through Thursdays, or 30 minutes past 12:00 o'clock Midnight on Fridays or Saturdays. Any minor accompanied by one of his parents, guardian or other adult person responsible for his care and custody is excepted from this prohibition.

Sec. 21.51. Penalty Against Minor.

Any minor violating the provisions of this ordinance shall be fined not less than \$3.00 nor more than \$25.00 for the first offense, not less than \$25.00 nor more than \$50.00 for the second offense, and not less than \$100.00 nor more than \$200.00 for a third offense.

Sec. 21.52. Penalty Against Parent or Guardian.

Any parent, guardian or other person having legal custody or control of any minor who shall permit or allow said minor to be upon any street, alley or any other public place within the City of Urbana, Illinois in violation of the provisions of any Section of this Chapter shall be also in violation of this ordinance and in event any such minor or child is held to be in violation of Section 21.49 or 21.50 of this Chapter a second time


within a 12 months period, then such parent, guardian or persons responsible for the care and custody of the minor violator shall be fined not less than \$25.00 nor more than \$50.00, and in event a minor is found to be in violation of said ordinance a third time during a 12 months period, then the parent, guardian or person responsible for the minor shall be fined not less than \$100.00 nor more than \$200.00.
