AN ORDINANCE AMENDING THE ANNUAL APPROPRIATION  
ORDINANCE OF THE CITY OF URBANA, ILLINOIS, FOR THE  
YEAR BEGINNING MAY 1, 1955 AND ENDING APRIL 30, 1956.

WHEREAS, the City Council of the City of Urbana, Illinois,  
did on the 18th day of July, A. D. 1955, adopt an ordinance  
entitled, "Annual Appropriation Bill of the City of Urbana,  
Illinois, for the Year Beginning May 1, 1955 and ending April  
30, 1956, and

WHEREAS, said Ordinance provided in section 16 thereof as  
follows:

"SECTION 16. Nothing herein shall be construed as prohibiting  
the redistribution of the funds herein appropriated, so that the  
amount herein appropriated for any express purpose, which shall  
later be found to be in excess of the amount actually needed for  
such purpose, may be allotted and added to the amount herein  
appropriated for some other express purpose which shall later be  
found to be less than the amount needed for such purpose; nor  
shall the same be construed so as to prohibit the addition of  
any amounts from revenue which may be received hereafter, which  
are not at this time anticipated or foreseen; nor shall anything  
herein be construed to prohibit the right to make such redistri-  
bution and allotment of the funds herein appropriated when needed  
for the purpose for which such amounts were appropriated." and

WHEREAS, it appears that insufficient amounts were appropriated  
for certain departments of said City hereinafter mentioned, and  
that excess funds were appropriated for certain departments here-  
inafter mentioned so that it is possible to redistribute such  
excess amounts to the departments for which insufficient funds  
were appropriated.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE  
CITY OF URBANA, ILLINOIS:

SECTION 1. That the Annual Appropriation Bill of the City  
of Urbana, Illinois, for the year beginning May 1, 1955, and  
ending April 30, 1956, is hereby amended as follows:

\$4,900.00 of the funds appropriated for the Current Expenses  
of Lights and Electrical Service Department in Paragraph 6 of  
Section 1 thereof, and


\$5,500.00 of the funds appropriated for the Current Expenses  
of the Building and Grounds Department in Paragraph 4 of Section 1  
thereof are hereby redistributed and re-appropriated for the current  
expenses of the Police Department as follows:

For salaries for five extra patrolmen for six months -\$9,750.00  
 For equipment and uniforms - - - - - 650.00  
 Total Re-appropriated for Police Department - - - \$10,400.00

\$30,600.00 of the funds appropriated for Fire Protection in Section 10 thereof are hereby redistributed and re-appropriated for the current expenses of the Street and Alley, Sewerage and Drainage Department, as follows:

For equipment - - - - - \$13,100.00  
 For salary of Assistant Building Inspector - - - 2,200.00  
 For Tree Removal - - - - - 15,000.00  
 For travel expense of Assistant Building Inspector - 300.00  
 Total Re-appropriated for Street Dept. - - \$30,600.00
