AN ORDINANCE FOR THE ANNEXATION OF TERRITORY

WHEREAS, it appears to the City Council of the City of Urbana, Illinois that a petition was filed with the County Clerk of Champaign County, Illinois, on the 22nd day of May, A. D. 1956, requesting the annexation of the territory hereinafter described, to the City of Urbana, Illinois, and requesting the Judge of the County Court of Champaign County to submit the question of the annexation of said territory to the corporate authorities of said City, said territory being described in said petition as follows, to-wit:

Commencing at a point Three Hundred Thirty feet (330') East of the Southwest corner of the Northwest Quarter of Section Nine (9) Township Nineteen (19) North, Range Nine (9) East of the Third Principal, thence North to the Southwest corner of Lot Three (3) of a subdivision of the West Half of the Northwest Quarter of said Section Nine (9), thence East Three Hundred Thirty feet (330'), thence North to the North line of Section Nine (9), thence West along the North line of Section Nine (9) and along the North line of Section Eight (8) to a point directly North of the West line of Lot Three (3) of a subdivision of the Northeast Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence South along the West line of said Lot Three (3) and along the West line of Lot Fourteen (14) of said subdivision to the Southwest corner of said Lot Fourteen (14), thence East along the South lines of Lots Fourteen (14) Fifteen (15) and Sixteen (16) of said subdivision to the center line of Cunningham Avenue (U.S. 45), thence in a Southwesterly direction along the center line of Cunningham Avenue (U.S. 45) to a point directly East of the North line of Lot Three (3) of J. T. Kaucher's Addition, thence West to the Northwest corner of Lot Three (3) of said J. T. Kaucher's Addition, thence South to the center line of Kerr Avenue, thence East to the center line of Cunningham Avenue, thence South to the South line of the Northeast Quarter of said Section Eight (8), thence East along the South line of the Northeast Quarter of said Section Eight (8) and along the South line of the Northwest Quarter of said Section Nine (9) to the place of beginning, all situated in the County of Champaign and State of Illinois,

And it further appearing to the City Council that said Judge of the County Court of Champaign County entered an order fixing the time of the hearing upon the petition, and the day for the hearing thereon to be the 14th day of June, A. D. 1956 at the hour of 9:30 o'clock A.M., DST, in the County Court Room in the Court House in the City of Urbana, Illinois.

And it further appearing to the City Council that a hearing was had in the County Court on said petition at said time after proper notice of said

hearing was made according to law by publication of a notice in the Champaign-Urbana Courier, and that pursuant to said notice, the Judge of said Court, at said hearing entered an order on the 14th day of June, A. D. 1956, directing that the question of the annexation of the above described territory to the City of Urbana, Illinois be submitted to the corporate authorities of said City for final action, and

Whereas, the City Council of the City of Urbana finds that a certified copy of the order of the County Court entered on the 14th day of June, A. D. 1956 was delivered to the City Clerk of the City of Urbana, Illinois, which said order finds that all of the necessary legal steps were taken by the petitioners for the annexation of said territory to the City of Urbana, and that the petition was signed by a majority of the owners of record of land in said territory and also by a majority of the electors residing in said territory, and that said territory is not within the corporate limits of any municipality, but is contiguous to the City of Urbana, Illinois, and

Whereas, it appears to the City Council that there were no objections filed in the County Court to the annexation of said territory to the City of Urbana, and

Whereas, the owners of Lot Four (4) of J. T. Kaucher's Addition to Urbana have petitioned that their lot be annexed to said City, and

Whereas, the owners of the lot described as follows, to-wit:

Commencing at the Southwest corner of the intersection of Cunningham Avenue and Kerr Avenue, thence West One Hundred Twenty-four feet (124'), thence South Fifty-six feet (56'), thence East to the West line of Cunningham Avenue, thence North to the place of beginning, all situated in Champaign County, Illinois,

have petitioned that said tract be annexed to the City of Urbana.

IT IS, THEREFORE, the opinion of more than two-thirds (2/3) of the duly elected aldermen of said City that it would be to the best interest of residents and land owners of the hereinafter described territory and for the best interest of the people of the City of Urbana that the hereinafter described territory be annexed to and become a part of the City of Urbana.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:


SECTION 1. That the territory described as follows, to-wit:

Commencing at a point Three Hundred Thirty feet (330') East of the Southwest corner of the Northwest Quarter of Section Nine (9) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence North to the Southwest corner of Lot Three (3) of a subdivision of the West Half of the Northwest Quarter of said Section Nine (9), thence East Three Hundred Thirty feet (330'), thence North to the North line of Section Nine (9), thence West along the North line of Section Nine (9) and along the North line of Section Eight (8) to a point directly North of the West line of Lot Three (3) of a subdivision of the Northeast Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence South along the West line of said Lot Three (3) and along the West line of Lot Fourteen (14) of said subdivision to the Southwest corner of said Lot Fourteen (14), thence East along the South lines of Lots Fourteen (14) Fifteen (15) and Sixteen (16) of said Subdivision to the center line of Cunningham Avenue (U.S. 45), thence in a Southwesterly direction along the center line of Cunningham Avenue (U.S. 45) to a point directly East of the North line of Lot Four (4) of J. T. Kaucher's Addition, thence West to the Northwest corner of Lot Four (4) of said J. T. Kaucher's Addition, thence South to a point Seventy-six (76) feet South of the center line of Kerr Avenue, thence East to the center line of Cunningham Avenue, thence South along the center line of Cunningham Avenue to the South line of the Northeast Quarter of said Section Eight (8), thence East along the South line of the Northeast Quarter of said Section Eight (8) and along the South line of the Northwest Quarter of said Section Nine (9) to the place of beginning, all situated in the County of Champaign and State of Illinois,


be and the same is hereby annexed to and shall become a part of the City of Urbana, Illinois, and that the corporate limits of said City be and the same shall be changed so as to include said territory within the corporate limits of said City.

SECTION 2. This ordinance shall be in full force and effect on the expiration of thirty (30) days from the date of its passage unless a referendum thereon shall be subsequently ordered by said City Council or unless a petition for such referendum shall be filed with the City Clerk of said City. In case of such a referendum, this ordinance shall be in full force and effect if a majority of the electors voting upon the question favor the annexation of said territory to the City of Urbana. If a majority of the electors voting upon the question vote against such annexation, then this ordinance shall become null and void.

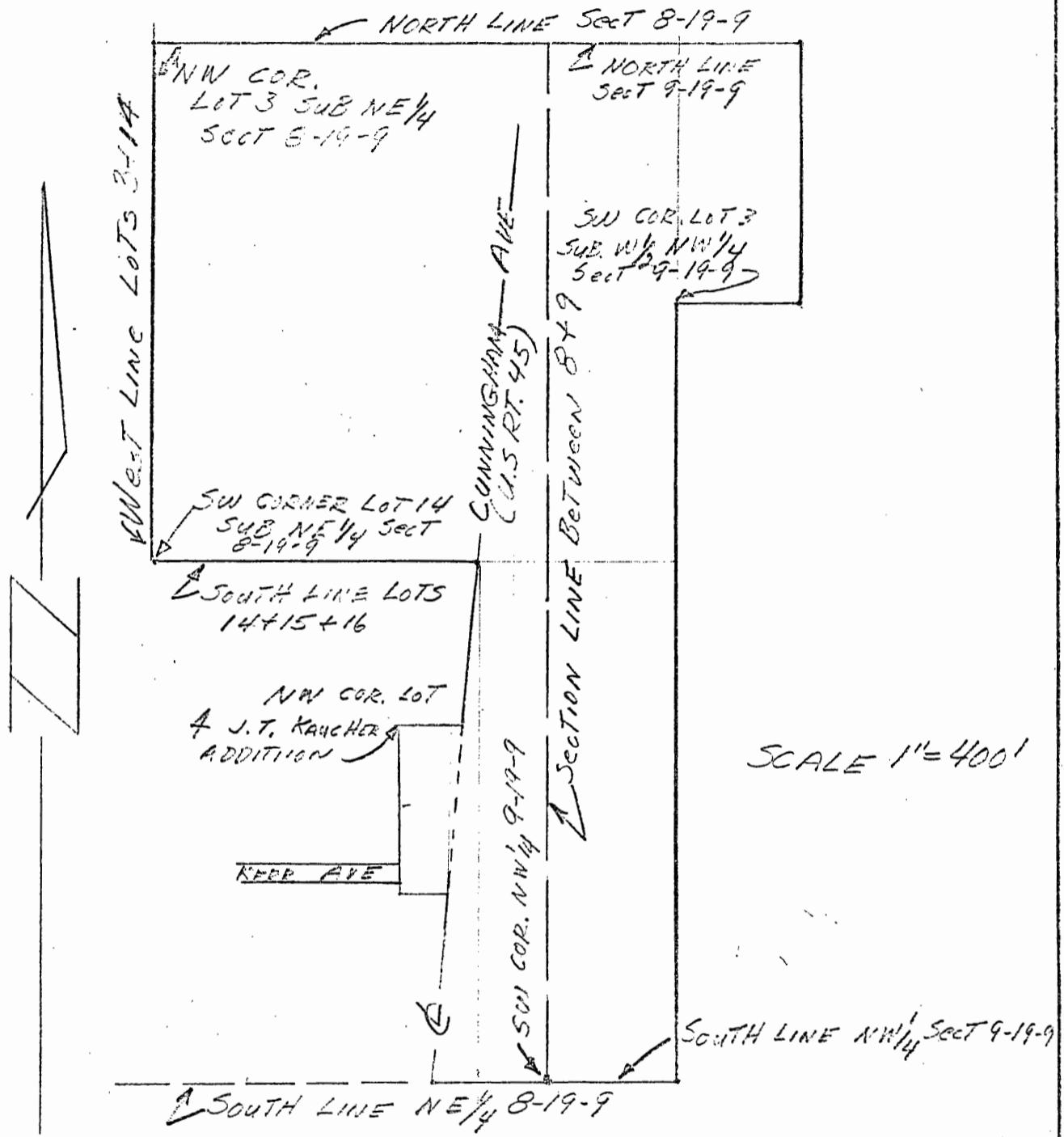
