AN ORDINANCE ADDING CERTAIN RECENTLY ANNEXED  
TERRITORIES TO CERTAIN WARDS OF THE CITY  
OF URBANA, ILLINOIS

---

WHEREAS, various tracts of real estate have been annexed to the City of Urbana subsequent to January 3, 1955, on which date the City Council of said City adopted an ordinance establishing ward boundaries for said City, and

WHEREAS, a large number of electors reside in said annexed areas not heretofore included in any of the seven (7) authorized wards of said City, and

WHEREAS, it appears to the City Council of said City that, in order to comply with the statutory requirement that the population of all wards shall be as nearly equal as practicable and that wards shall be of as compact and contiguous territory as practicable, it is necessary and desirable to change the boundaries of certain wards to include within the boundaries thereof, recently annexed territory contiguous to said wards;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. The boundaries of the seven (7) wards of the City of Urbana are hereby changed so that said wards shall henceforth include the areas bounded as follows:

FIRST WARD - Commencing at the center of the intersection of Illinois Street and Broadway Avenue, thence North to the center line of Bailey Street, thence East along the center line of Bailey Street to the East line of Division Street, thence North along the East line of Division Street to the Northwest corner of Lot 13 of a subdivision of the Northeast Quarter of Section 8, Township 19 North, Range 9 East of the Third Principal Meridian, thence East to the Northeast corner of said Lot 13, thence North to the North line of said Section 8, thence East along the North line of said Section 8 and continuing along the North line of Section 9, Township 19 North, Range 9 East of the Third Principal Meridian to a point in the public road directly North of the Northeast corner of Lot 3 of a subdivision of the West Half of the Northwest Quarter of Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, thence South to the Southeast corner of said Lot 3, thence West 330 feet, thence South to the South line of the Northwest Quarter of said Section 9, thence East along the South line of the Northwest Quarter of said Section 9 to the center of said Section 9, thence South along the center line of said

Section 9 to the center of U. S. Route 150, thence in a Westerly direction along the center line of U. S. Route 150 to the East line of Oak Street extended, thence South along the West line of the East Half of the Southwest Quarter of said Section 9 to the right-of-way line of the Peoria and Eastern Railroad, thence East along said North right-of-way line to a point directly North of the Northwest corner of Lot 6 of Laura M. Kegley's Subdivision, thence in an Easterly direction along the South right-of-way line of the Peoria and Eastern Railroad right-of-way to the East line of the Southwest Quarter of the Southwest Quarter of Section 10, Township 19 North, Range 9 East of the Third Principal Meridian, thence South to the center line of Main Street extended, thence East along the center line of Main Street extended to the East line of Glover Street, thence South along the center line of Glover Street to the center line of Illinois Street, thence West along the center line of Illinois Street to the point of beginning.

SECOND WARD - Commencing at the center of the intersection of Main Street and Broadway Avenue, thence North along the center line of Broadway Avenue to a point directly East of the Southeast corner of Lot 7 of a subdivision of the Northeast Quarter of Section 8, Township 19 North, Range 9 East of the Third Principal Meridian, thence West to the center line of Section 8, thence South to the center of Section 8, thence West to the center of the intersection of Fairview Avenue and Coler Avenue, thence North along the center line of Coler Avenue to a point 30 feet East of the Northeast corner of Lot 4 of B. B. Bunn's Addition, thence West to the East line of Busey Avenue, thence North to the South line of Sunset Drive, thence West to the center line of Lincoln Avenue, thence South to the center line of Springfield Avenue, thence East along the center line of Springfield Avenue and along the center line of Main Street to the place of beginning.

WARD THREE - Commencing at the intersection of the center line of Lincoln Avenue and the center line of Fairview Avenue, thence West to a point 30 feet South of the Southeast corner of Lot 10 of O. S. Carman's Third Subdivision thence North 130 feet, thence West to the Northwest corner of Lot 8 of said O. S. Carman's Third Subdivision, thence North to the Northeast corner of Lot 1 of O. S. Carman's Third Subdivision, thence West to a point 814.99 feet West of the center line of Goodwin Avenue, thence North 334 feet, thence West 470.14 feet, thence North 345.18 feet, thence East 315.15 feet, thence North 1,076.67 feet, thence West 368.64 feet, thence South 325 feet, thence West 291.36 feet, thence South along the center line of Goodwin Avenue to the North line of the Southwest Quarter of the Northeast Quarter of Section 7, Township 19 North, Range 9 East of the Third Principal Meridian, thence West to the West line of the Dunbar Project of the Champaign County Housing Authority, thence North 327 feet, thence West to the center line of Wright Street, thence South along the center line of Wright Street to the center line of Springfield Avenue, thence East along the center line of Springfield Avenue to the center line of Lincoln Avenue, thence North to the point of beginning.

FOURTH WARD - Commencing at the center of the intersection of Lincoln Avenue and Springfield Avenue, thence West along

the center line of Springfield Avenue to the center line of Wright Street, thence South along the center line of Wright Street and along said line extended to the North line of Mt. Hope Cemetery, thence East to the East line of Mt. Hope Cemetery, thence South along the East boundary of said Cemetery to the center line of Florida Avenue, thence West to the Northwest corner of the Northeast Quarter of Section 19, Township 19, North, Range 9 East of the Third Principal Meridian, thence South to the Southwest corner of the North Half of the Northeast Quarter of said Section 19, thence East to the center line of Lincoln Avenue, thence North to the place of beginning.

**FIFTH WARD** - Commencing at the intersection of Main Street and Broadway Avenue in the City of Urbana, Illinois, thence West along the center line of Main Street to the point of intersection of Main Street and Springfield Avenue, thence West along the center line of Springfield Avenue to the center of the intersection of Lincoln Avenue and Springfield Avenue, thence South along the center line of Lincoln Avenue to the center line of Nevada Street, thence East along the center line of Nevada Street to the center line of McCullough Street, thence South along the center line of McCullough Street to the center line of Washington Street, thence East along the center line of Washington Street to the center line of Broadway, thence North along the center line of Broadway Avenue to the place of beginning.

**SIXTH WARD:-** Commencing at the center of the intersection of Broadway Avenue and Illinois Street, thence East along the center line of Illinois Street to the East line of Glover Avenue, thence South to the Southwesterly line of the Wabash Railway Company right-of-way, thence in a Southwesterly direction along the Southwesterly right-of-way line of the Wabash Railway Company to the East line of Champaign-Urbana Amvets Subdivision, thence South to the Southeast corner of the Southwest Quarter of the Southeast Quarter of Section 16, Township 19 North, Range 9 East of the Third Principal Meridian, thence West to the Southwest corner of Lot 5 of Block 16 of Champaign-Urbana Amvets Subdivision, thence North to the North point of Lot 1 of said Block 16 of Champaign-Urbana Amvets Subdivision, thence West to the center line of the Philo Road, thence South to the center line of Florida Avenue, thence West to the center line of Vine Street, thence North to the center line of Washington Street, thence West to the center line of Broadway Avenue, thence North to the place of beginning.

**SEVENTH WARD** - Commencing at the center of the intersection of Nevada Street and Lincoln Avenue, thence South to the Southwest corner of the North Half of the Northwest Quarter of Section 20, Township 19 North, Range 9 East of the Third Principal Meridian, thence East to the center line of Race Street, thence South to the center line of Mumford Drive, thence East 195 feet, thence North to the South line of Montclair Addition, thence East along the South line of Montclair Addition to the Northwest corner of Lot 43 of University Downs Fourth Plat, thence South along the West line of said Lot 43 to the North line of Mumford


Drive, thence in a Southeasterly direction across Mumford Drive to the Northwest corner of Lot 123 of University Downs Fourth Plat, thence South along the West line of Lot 123 of University Downs Fourth Plat a distance of 73.92 feet, thence in a Southeasterly direction along the Southwestern boundary of said lot 123 to the South line of said lot, thence North 5 feet, thence in a Southeasterly direction along a line which is 5 feet Northeast of the Southwest line of Lot 122 of University Downs Fourth Plat to the West line of Lot 121 of University Downs Fourth Plat, thence in a Northerly direction along the West line of Lot 121 of University Downs Fourth Plat to the South line of Mumford Drive, thence in a Southeasterly direction along the South line of Mumford Drive to the Northeast corner of Lot 121 of University Downs Fourth Plat, thence South to the Southeast corner of Lot 121 of University Downs Fourth Plat, thence West along the South line of Lots 121 and 122 of University Downs Fourth Plat to the Northeast corner of Lot 92 of Third Addition to University Downs, thence South along the East line of said Lot 92 to the Southeast corner of said Lot 92, thence in a Southerly direction across Burlison Drive to the Northeast corner of Lot 69 of Third Addition to University Downs, thence in a Southerly direction to the Southeast corner of said Lot 69, thence in a Southeasterly direction along the back lines of Lots 70 and 71 of Third Addition to University Downs to the Northwest corner of Lot 72 of Third Addition to University Downs, thence in a Southeasterly and South direction along the back lines of Lots 72, 73, 74, 75, 76 and 77 of Third Addition to University Downs to the Southeast corner of said Lot 77, thence West to the center line of Boudreau Drive, thence South to the center line of G Huff Drive, thence West to the West line of Ennis Downs Subdivision, thence South to the South line of Ennis Downs Subdivision, thence East to the East line of Ennis Downs Subdivision, thence North to the South line of the North Half of Section 20, thence East along the South line of the North Half of Section 20 to a point 12 feet South of the South point of Lot 237 of University Downs Ninth Plat, thence in a North-easterly direction along the South lines of Lots 237, 236 and 235 of University Downs Ninth Plat to the Southwest corner of Lot 228 thereof, thence East to the East line of University Downs Ninth Plat, thence North to the center line of Colorado Avenue, thence West along the center line of Colorado Avenue to the center line of Vine Street, thence North along the center line of Vine Street to the center line of Washington Street, thence West along the center line of Washington Street to the center line of McCullough Street, thence North along the center line of McCullough Street to the center line of Nevada Street, thence West along the center line of Nevada Street to the place of beginning.

SECTION 2. The City Clerk of the City of Urbana is hereby authorized and directed to cause to be printed a sufficient number of maps of the various wards as hereby created so that it will be convenient for the electors of the City of Urbana to ascertain their voting rights


in connection with the municipal elections to be henceforth conducted.

SECTION 3. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
