AN ORDINANCE PROVIDING FOR THE TAKING OF A CENSUS IN AREAS
ANNEXED TO THE CITY OF URBANA, ILLINOIS SUBSEQUENT TO
SEPTEMBER 7, 1954

WHEREAS, it is provided in Paragraph 424 of Chapter 120 of Illinois Revised Statutes of 1955 that the Department of Finance of the State of Illinois shall allot to each municipality, its share of the amount of Motor Fuel Tax Funds apportioned to the municipalities which shall be in proportion to the population of such municipalities as determined by the last Federal Census, and that if territory is annexed to any municipality subsequent to the time of the last preceding Federal Census, the corporate authorities of such municipality may cause a census to be taken of such annexed territory and the population so ascertained for such territory shall then be added to the population of the municipality as determined by the last preceding Federal Census for the purpose of determining the allotment for that municipality, and further providing that any census so taken by a municipality shall be certified to the Department of Finance by the Clerk of such municipality, and

WHEREAS, the last Federal Census made in the City of Urbana, Illinois did not cover or include any of the territory annexed to said City subsequent to the 1st day of July, A. D. 1950, and

WHEREAS, a census was taken under the provisions of Paragraph 424 of Chapter 120 of the Illinois Revised Statutes of 1953 by virtue of the provisions of an ordinance adopted September 7, 1954, and

WHEREAS, a large amount of territory has been legally annexed to the City of Urbana since the census conducted pursuant to said ordinance of September 7, 1954 in which territory there is residing a large number of people, which number it is necessary to ascertain for the purpose of determining the proportion of Motor Fuel Tax Funds to which the City of Urbana should be entitled to receive from the State of Illinois:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That a census shall be taken for the purpose of ascertaining the population in territories which have been annexed to the City of Urbana subsequent to September 7, 1954, said territories having been annexed to the City of Urbana on the dates shown and being specifically described as follows, to-wit:

- 1) Beginning at the Northeast corner of the Southeast Quarter of the Northeast Quarter of Section 20, Township 19 North, Range 9 East of the 3rd Principal Meridian, thence South $0^{\circ} 29'$ East 443.0 feet, thence South $89^{\circ} 38'$ West 185 feet, thence South $0^{\circ} 29'$ East 35 feet, thence South $89^{\circ} 38'$ West 380.48 feet, thence North $0^{\circ} 38'$ West 478 feet to the center line of Colorado Avenue, thence North $89^{\circ} 38'$ East 566.70 feet to the place of beginning, situated in Champaign County, Illinois,

which said territory was annexed by an ordinance recorded in the Recorder's Office in Champaign County, Illinois on February 3, 1955.

- 2) Commencing at a point on the East line of the Southeast Quarter of the Northeast Quarter of Section 20, Township 19 North, Range 9 East of the 3rd Principal Meridian, said point being South $0^{\circ} 29'$ East, with reference to the true meridian, a distance of 443.00 feet from the Northeast corner of said Southeast Quarter of the Northeast Quarter of Section 20, aforesaid, thence South $0^{\circ} 29'$ East a distance of 585.00 feet, thence South $89^{\circ} 38'$ West a distance of 563.63 feet, thence South $49^{\circ} 59'$ West a distance of 120.51 feet, thence South $0^{\circ} 38'$ East 12.00 feet to the quarter section line, thence South $89^{\circ} 31'$ West a distance of 177.00 feet, thence North $0^{\circ} 38'$ West a distance of 424.91 feet, thence North $49^{\circ} 59'$ East a distance of 195.41 feet, thence South $40^{\circ} 01'$ East a distance of 60 feet, thence North $49^{\circ} 59'$ East a distance of 130.53 feet, thence North $0^{\circ} 38'$ West a distance of 33.73 feet, thence North $89^{\circ} 38'$ East a distance of 175.00 feet, thence North $0^{\circ} 38'$ West a distance of 100.00 feet, thence North $89^{\circ} 38'$ East a distance of 115.00 feet, thence North $0^{\circ} 38'$ West a distance of 125 feet, thence North $89^{\circ} 38'$ East a distance of 380.48 feet, thence North $0^{\circ} 29'$ West a distance of 35 feet, thence North $89^{\circ} 38'$ East a distance of 185 feet to the point of beginning, containing 13.9 acres, more or less, all as shown on the attached plat, and situated in Champaign County, Illinois,

excepting from the above described tract of land that portion of the West 175 feet of the Southeast Quarter of the Northeast Quarter of said Section 20, lying within the above described tract of land, said exception having heretofore been annexed to the City of Urbana, Illinois, with other lands.

- 3) Commencing at the intersection of the South line of Oregon Street and the East line of Glover Avenue in the City of Urbana, County of Champaign and State of Illinois, thence South along an extension of the East line of Glover Avenue to the Northeast line of the Wabash Railroad Company right-of-way, thence in a Southwesterly direction across said Railroad right-of-way and across the Philo Road to the East point of Lot Fifty-eight (58) of Martha C. Hubbard's Second Addition, thence West along the South line of Lot Fifty-eight (58) of Martha C. Hubbard's Second Addition to the East line of Cottage Grove Avenue, thence North along the East line of Cottage Grove Avenue to a point One Hundred Five feet (105') North of the center line of Washington Street, thence East to a point directly South of the Southeast corner of Lot Sixty-six (66) of Martha C. Hubbard's Second Addition, thence North along the East lines of Lot Sixty-six (66) and Sixty-three (63) of Martha C. Hubbard's Second Addition to the South line of Oregon Street, thence East along the South line of Oregon Street to the point of beginning, all situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on October 8, 1955.

- 4) Commencing at the intersection of the West line of Lot Sixty-five (65) of Martha C. Hubbard's Second Addition and the Northeast right-of-way line of the Wabash Railroad Company in the City of Urbana, County of Champaign and State of Illinois, thence in a Southeasterly direction along the Northeast right-of-way line of said Wabash Railroad Company right-of-way to the South point of Lot Sixty-six (66) of Martha C. Hubbard's Second Addition, thence South to a point One Hundred Five feet (105') North of the center line of Washington Street extended, thence West to the East line of Cottage Grove Avenue, thence North along the East line of Cottage Grove Avenue to the point of beginning, all situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on October 18, 1955.

- 5) Commencing at a point One Hundred Eighty-three feet (183') East of the Southwest corner of the Southeast Quarter of the Southeast Quarter of Section Seventeen (17), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence North to the center line of Pennsylvania Avenue, thence East along the center line of Pennsylvania Avenue to a point One Hundred Thirty-four feet (134') West of the East line of the Southeast Quarter of the Southeast Quarter of said Section Seventeen (17), thence South to the South line of said Southeast Quarter of the Southeast Quarter of said Section Seventeen (17), thence West along the center line of Florida Avenue to the point of beginning, all situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on December 7, 1955.

- 6) Commencing at the intersection of the existing boundary line of the corporate limits of the City of Urbana, Illinois, and the North right of way line of S.B.I. Route 10 of the State of Illinois for a place of beginning, thence Easterly along said right of way line to the center line of Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, in Champaign County, Illinois, thence North along the center line of said section to the Northeast corner of the East Half of the Southwest Quarter of said section, thence West to the Northwest corner of the East Half of the Southwest Quarter of said section, being a point on the existing boundary line of the corporate limits of the City of Urbana, Illinois, thence South along the existing boundary line of the corporate limits of the City of Urbana, Illinois, to the place of beginning, situated in Champaign County, Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on December 7, 1955.

- 7) Commencing at the Northeast corner of the Northeast Quarter of the Northwest Quarter of the Southeast Quarter of Section Twenty (20) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence South to the Southeast corner of said Northeast Quarter of the Northwest Quarter of the Southeast Quarter of said Section Twenty (20), thence West to the Southwest corner of said Northeast Quarter of the Northwest Quarter of the Southeast Quarter, thence North to the Northwest corner of said Northeast Quarter of the Northwest Quarter of the Southeast Quarter of said Section Twenty (20), thence East to the place of beginning, all situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on January 5, 1956.

- 8) Commencing at a point on the South line of Fairlawn Village One Hundred Thirty-four feet (134') West of the East line of Section Seventeen (17), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence West to a point One Hundred Eighty-three feet (183') East of the West line of the East Half of the Southeast Quarter of said Section Seventeen (17), thence South to the center line of Pennsylvania Avenue, thence East along the center line of Pennsylvania Avenue to a point One Hundred Thirty-four (134) feet West of the East line of said Section Seventeen (17), thence North to the place of beginning, all situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on December 23, 1955.

- 9) Commencing at the Northeast corner of Lot Seventy-eight (78) of University Downs, thence West to the center line of Boudreau Drive, thence South along the center line of Boudreau Drive to the North line of G Huff Drive, thence East along the North line of G Huff Drive to the Southeast corner of Lot Seventy-eight (78) of University Downs, thence North to the place of beginning, all situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on January 9, 1956.

- 10) Commencing on the center line of Race Street at the Southwest corner of the South Half of the South Half of the Northwest Quarter of the Northeast Quarter of Section Twenty (20), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence South along the center line of Race Street to the center line of Mumford Drive, thence East along the center line of Mumford Drive One Hundred Ninety-five feet (195'), thence North along the East lines of Lots One (1) and Two (2) of First Flattening of University Downs to the South line of Montclair Addition, thence West to the place of beginning, all situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on January 9, 1956.

11) Commencing at the/intersection of Lincoln Avenue and Fairview Avenue, thence North along the center line of Lincoln Avenue Four Hundred Sixty-eight feet (468'), thence East along the North line of Lot Two (2) of Linview Subdivision One Hundred Eighty-three feet (183') to the Northeast corner of said Lot Two (2), thence South Eight feet (8'), thence East to the West line of Carman's Subdivision, thence North along the West line of Carman's Subdivision to the Northwest corner of Lot One (1) of said Carman's Subdivision, thence East to the center line of Eusey Avenue, thence South along the center line of Eusey Avenue to the North line of M. D. Busey's First Addition, thence West along the North line of said M. D. Busey's First Addition to the East line of Linview Subdivision, thence South along the East line of Linview Subdivision to the center line of Fairview Avenue, thence West along the center line of Fairview Avenue to the place of beginning, all situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on February 16, 1956.

- 12) Commencing at a point Seventy (70) feet East of the Southwest corner of Lot Eighteen (18) of First Replat of Elm Knoll Addition in the Northeast Quarter of Section Twenty (20), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, in Champaign County, Illinois, thence South to the North line of Montclair Addition, thence East along the North line of Montclair Addition, to the center line of Vine Street, thence North along the center line of Vine Street to a point Thirty-three feet (33') East of the Southeast corner of Lot Sixteen (16) of First Replat of Elm Knoll Addition, thence West Five Hundred Ninety-one feet (591') to the place of beginning, all situated in the County of Champaign and State of Illinois.

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on March 20, 1956.

- 13) Commencing at the Northwest corner of the South Half of the Southeast Quarter of the Southwest Quarter of Section Sixteen (16) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence East to the Northeast corner of the South Half of the Southeast Quarter of the Southwest Quarter of said Section Sixteen (16), thence South to the Southeast corner of the South Half of the Southeast Quarter of the Southwest Quarter of said Section Sixteen (16), thence West to the Southwest corner of the South Half of the Southeast Quarter of the Southwest Quarter of said Section Sixteen (16), thence North to the place of beginning, containing twenty (20) acres, more or less, situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on April 9, 1956.

- 14) Commencing at a point Five Hundred Seven and Five Tenths feet (507.5') North of the Southwest corner of the Southeast Quarter of the Northeast Quarter of Section Seven (7), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence East Eight Hundred Fourteen and Ninety-nine Hundredths feet (814.99'), thence North Three Hundred Thirty-four feet (334'), thence West Four Hundred Seventy and Fourteen Hundredths feet (470.14') thence North Three Hundred Forty-five and Eighteen Hundredths feet (345.18'), thence East Three Hundred Fifteen and Fifteen Hundredths feet (315.15'), thence North One Thousand Seventy-six and Sixty-seven Hundredths feet (1,076.67'), thence West Three Hundred Sixty-eight and Sixty-four Hundredths feet (368.64'), thence South Three Hundred Twenty-five feet (325'), thence West Two Hundred Ninety-one and Thirty-six Hundredths feet (291.36'), thence South One Thousand Four Hundred Thirty and Eighty-five Hundredths feet (1,430.85') to the point of beginning, all situated in the County of Champaign and State of Illinois.

- (17) Commencing at the intersection of the center line of Broadway Avenue and the North line of Oakland Avenue in the City of Urbana, Illinois, thence North to the

center line of Bailey Street, thence East along the center line of Bailey Street, to the center line of Division Avenue, thence South along the center line of Division Avenue to the North line of Oakland Avenue, thence West along the North line of Oakland Avenue, to the place of beginning, all situated in the County of Champaign and State of Illinois,

which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on September 6, 1956.

- 18) Commencing at the Northeast corner of Lot Thirteen (13) of a Subdivision of the Northeast Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, in Champaign County, Illinois, thence West to the center line of Division Avenue, thence South along the center line of Division Avenue to the South line of said Lot Thirteen (13), thence East along the South line of said Lot Thirteen (13) to the Southeast corner thereof, thence North along the East line of said Lot Thirteen (13) to the place of beginning, all situated in the County of Champaign and State of Illinois


which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on August 28, 1956.

- 19) Commencing at the center of the intersection of Cunningham Avenue (U. S. Route 45) and Barr Avenue on the South line of the Northeast Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian in Champaign County, Illinois, thence West along the South line of the Northeast Quarter of said Section Eight (8) to the East line of the Champaign County Housing Authority Land, thence North along the East line of said Housing Authority Land to the Northeast corner thereof, thence West along the North boundary of said Housing Authority Land to a point directly South of the East line of Division Street, thence North to the center line of Kerr Avenue, thence East along the center line of Kerr Avenue One Hundred Ten feet (110') to a point Twenty feet (20') South of the Southeast corner of Lot Eleven (11) of Orville J. Hewkin's Subdivision, thence North along the East line of Orville J. Hewkin's Subdivision to the South line of Lot Thirteen (13) of a subdivision of the Northeast Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence East along the South lines of Lots Fourteen (14) Fifteen (15) and Sixteen (16) of said subdivision to the center line of Cunningham Avenue (U. S. Route 45), thence in a Southwesterly direction along the center line of Cunningham Avenue (U. S. Route 45) to a point directly East of the North line of Lot Four (4) of J. T. Kaucher's Addition, thence West to the Northwest corner of said Lot Four (4) of J. T. Kaucher's Addition, thence South to a point Seventy-six feet (76') South of the center line of Kerr Avenue, thence East to the center line of Cunningham Avenue, thence South along the center

line of Cunningham Avenue to the point of beginning, all situated in the County of Champaign and State of Illinois, which said territory was annexed to the City of Urbana by an ordinance recorded in the Recorder's Office of Champaign County, Illinois on September 6, 1956.

SECTION 2. That the Mayor with the consent of the City Council shall appoint a census taker and such assistant census takers as may be needed to conduct such census and said persons shall be paid at the rate of 10¢ per head for the taking of said census and for the tabulation of the results thereof. When said census is completed, the results thereof shall be filed with the City Clerk of the City of Urbana and a certified copy of said census along with a certified copy of this ordinance shall be forwarded to the Department of Finance of the State of Illinois by the City Clerk of the City of Urbana.
