AN ORDINANCE AMENDING THE CODE OF THE CITY OF URBANA. ILLINOIS OF 1954

BE IT ORDAINED BY THE CETY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

That the following amendments are hereby made to the Code of the City of Urbana, Illinois of 1954:

SECTION 1. Section 20.103 of said Code is hereby amended to read as follows:

Section 20.103. Vehicles Exempt from Article.

The provisions of this article shall not apply to vehicles which are owned by the State or any political subdivision thereof, public corporations, the United States Government or any political subdivision thereof, vehicles validly licensed or taxed by another municipality providing evidence of such licensing or taxing can be shown, any vehicle which is licensed under the provisions of any other ordinance of this city, vehicles which operate in Interstate Commerce, to vehicles either new or used which are held or owned by dealers for sale as new or used vehicles and which contain dealers license plates issued by the State, nor to vehicles operated and licensed from a business address in another city even though owned by a resident of this city.

SECTION 2. Section 20.104 of said Code is hereby amended to read as follows:

Section 20.104. License Required.

Every owner or operator of a motor vehicle, motor cycle or motor bicycle, who resides within the City and persons, firms and corporations operating business and commercial vehicles from a business address within said City, shall pay to the City Clerk of the City once each fiscal year for each vehicle owned or operated or used on any public street or highway within the City, a tax or license fee for each such vehicle so used, owned or operated. Any person who has actually lived in the City of Urbana for a period of sixty (60) days shall be presumed to be a resident of the City for the purposes of this article.

SECTION 3. Section 20.108 of said Code is hereby amended to read as follows:

Section 20.108. Same -- Time of Payment; Duration.

The license fee or tax shall be due and payable annually in advance on the 1st day of May of each calendar year and each such license shall expire on the 30th day of April of the following calendar year, provided, however, that each owner or operator of a vehicle who becomes subject to this article after the expiration of the first six (6) months of the fiscal year of the City shall pay one-half of the annual fee provided for. All persons shall become subject to this article upon establishing a place of abode within the City of Urbana and any person establishing such place of abode within the first six (6) months of the fiscal year of the City shall pay the entire amount of the license fee for such fiscal year even though such abode might be established within the last sixty (60) days of the first half of such fiscal year. The fiscal year of the City of Urbana commences on May 1 of each calendar year and terminates on the 30th day of April of the following calendar year.
