

ORDINANCE VACATING PART OF AN ALLEY

WHEREAS, the owners of Lots Three (3) and Four (4) of a Sub-division of Out Lot Ten (10) of James S. Busey's Addition of Out Lots to Urbana, County of Champaign and State of Illinois, have requested the City of Urbana, Illinois to vacate that alley lying on the East side of Lot Four (4) and the West Side of Lot Three (3) of a Subdivision of Out Lot Ten (10) of James S. Busey's Addition of Out Lots to Urbana, in Champaign County, Illinois, between Oregon Street and the East-West alley that lies between Oregon Street and Nevada Street in Urbana, Illinois, and

WHEREAS, the owners of Lots Three (3) and Four (4) of a Sub-division of Out Lot Ten (10) of James S. Busey's Addition of Out Lots to Urbana, County of Champaign and State of Illinois, being the owners of all the land adjoining said alley, have agreed to the closing of said alley, and

WHEREAS, it appears to the City Council of the said City of Urbana that the public interest will be subserved with the closing of said alley as aforesaid.

THEREFORE, be it ordained by the City Council of the City of Urbana:

1. That the City Council of Urbana, Illinois hereby vacates and releases to the owners of the abutting property all of the right, title and interest of the City to that portion of an alley lying on the East side of Lot Four (4) and the West side of Lot Three (3) of a Subdivision of Out Lot Ten (10) of James S. Busey's Addition of Out Lots to Urbana, County of Champaign and State of Illinois, between Oregon Street and the East-West alley which lies between Oregon Street and Nevada Street in Urbana, Illinois; reserving, however, to any public utility which now owns any facilities in said alley way, an easement of ingress and egress to such facilities for the maintenance, renewal, and reconstruction thereof.

2. This ordinance shall take effect and be in force from and after its passage and approval.
