

AN ORDINANCE ANNEXING CERTAIN
TERRITORY TO THE CITY
URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois that a petition was filed with the City Clerk of the City of Urbana, Illinois on the 17th day of June, A. D. 1957 requesting the annexation of the territory hereinafter described, which said petition was signed under oath by all of the owners of record of real estate and all of the electors residing in said territory, and

WHEREAS, at least two-thirds of the aldermen are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois that said territory be annexed to, and made a part of the city limits of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:


SECTION 1. That the territory described as follows, to-wit:

Beginning on the North line of the Southeast Quarter of Section Five (5) Township Nineteen (19) North Range Nine (9) East of the Third Principal Meridian, One Hundred Fifty-four and Sixty-five Hundredths (154.65) feet West of the Northeast corner of the Southeast Quarter of said Section Five (5), thence West along said line Three Hundred Fifteen (315) feet, thence South Three Hundred Thirty-six and Four Tenths (336.4) feet, thence South Sixteen (16) degrees, Fifty-four (54) minutes West Six Hundred Eighty-two and Seventy-eight Hundredths (682.78) feet, thence South Three Hundred Thirty and Nine Tenths (330.9) feet to the South line of said Section Five (5), thence East along said Section line Three Hundred Ninety-six and Eight Hundredths (396.08) feet, thence North Six Hundred Sixty and Eighty-one Hundredths (660.81) feet thence East Eighty-four (84) feet, thence North One Hundred Six and Twenty-five Hundredths (106.25) feet, thence East Thirty-two (32) feet, thence North Five Hundred Fifty-seven and Three Tenths (557.3) feet to the point of beginning, containing Ten and Seven Tenths (10.7) acres more or less, all in Champaign County, Illinois.

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territory within the corporate limits of said City.


