

AN ORDINANCE FIXING COMPENSATION OF OFFICERS AND EMPLOYEES
OF THE CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION I. That beginning May 1, 1958, the monthly salaries of the following named officers and employees of the City of Urbana, Illinois shall be as follows:

SECTION II. Local Improvement fees on all projects commenced after May 1, 1957, based upon the actual construction cost of each project, shall be paid into the General Corporate Fund from said projects in lieu of paying such fees to the Corporation Counsel. The attorney fees from projects commenced prior to May 1, 1957, shall be apportioned between the attorney performing the work prior to May 1, 1957, and the General Corporate Fund in proportion to the amount of legal work performed prior to and subsequent to said date, said proportion to be determined by the County Judge of Champaign County, the Council to have the right to appeal.

SECTION III. Beginning May 1, 1958, extra help employed by the City Engineer on local improvements projects shall be paid from the General Fund at an hourly rate to be determined by the City Council. All engineering fees from local improvements commenced after May 1, 1958, shall be paid into the General Corporate Fund.

SECTION IV. For each regular or special meeting of the City Council attended by him, each alderman shall receive a compensation of. \$10.00.

SECTION V. Regular street department employees shall receive wages at the rate of \$326.02 per month. Emergency call men in street department shall receive \$351.02 per month. All other employees in the Street Department or working in the Sewer or Drainage Department or Electrical Department who shall be employed by the City shall receive \$1.60 per hour.

SECTION VI. Each member of the Civil Service Commission shall receive \$10.00 per year as payment for his services on the said Commission.

SECTION VII. All ordinances or parts of ordinances in conflict herewith, are hereby repealed.
