

ORDINANCE FOR THE LOCATION OF  
FIRE HYDRANTS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
URBANA, ILLINOIS:

That there is a necessity for additional fire hydrants at the following specified locations, and that the hydrants be placed and installed at such locations by the Northern Illinois Water Corporation, and that the City Clerk of the City of Urbana, Illinois, is hereby directed to send a certified copy of this Ordinance to the Northern Illinois Water Corporation.

Preference is herein expressed and directed for the location of the fire hydrants during the years 1959, 1960 and 1961.

Locations for fire hydrants in the City of Urbana, are as follows:

Year 1959, Fire Hydrant Locations.

- At the intersection of Broadway and Thompson Street.
- At the corner of Elm Street and Busey Avenue,
- At the intersection of High and Maple Streets.
- At the intersection of Michigan and Carle Avenues.
- At the intersection of Pennsylvania and Carle Avenues.
- At the intersection of Vermont and Carle Avenues.
- At the intersection of Vermont and Busey Avenues.
- At the intersection of Delaware and Lincoln Avenues.
- At the intersection of Vermont and Lincoln Avenues.
- 2 fire hydrants on Pleasant Street.
- On Vine Street in the Sunnycrest area.
- At the intersection of Mumford and G.Huff Drives.
- On Douglas Avenue mid-way between Iowa Street and Indiana Avenue.

Year 1960, Fire Hydrant Locations.

- At the corner of Hartle Avenue and Main Street.
- At the corner of Geraldine and Kerr Avenues.
- At the corner of Main Street and Glover Avenue.
- At the intersection of High and Cedar Streets.
- At the intersection of High Street and Coler Avenue.
- At the intersection of California Street and Broadway.
- At the intersection of California and Race Streets.
- At the intersection of California Street and Coler Avenue.
- At the intersection of California Street and Busey Avenue.
- At the intersection of California Street and Urbana Avenue.
- At the intersection of California and Vine Streets.
- At the intersection of California and Maple Streets.
- At the intersection of California and Grove Streets.
- At the intersection of California and Lynn Streets.
- At the intersection of California Street and College Grove Avenue.
- At the intersection of Illinois Street and Urbana Avenue.


Year 1961, Fire Hydrant Locations.

- At the corner of Golf View Drive and Country Club Road.
- At the corner of Fairview Avenue and Gregory Street.
- At the corner of Fairview Avenue and Orchard Street.
- At the corner of McCullough Avenue and Park Street.
- At the corner of Clark and Harvey Streets.
- At the intersection of Springfield Avenue and Birch Street.


At the corner of Water and Walnut Streets.  
At the intersection of High and Birch Streets.  
At the intersection of High and Orchard Streets.  
At the intersection of California Street and McCullough Avenue.  
At the intersection of Cedar and Nevada Streets.  
At the corner of Broadway and Bailey Avenue.  
At the corner of Berkley Avenue and Thompson Street.  
At the intersection of California and Cedar Streets.

This ordinance rescinds all prior ordinances as to the location of additional hydrants in regard to hydrants not already in location at the present time.


