

AN ORDINANCE TO AMEND THE ORDINANCE CHANGING THE BOUNDARIES OF WARDS WITHIN THE CITY OF URBANA, ILLINOIS, AND ADDING CERTAIN ANNEXED TERRITORIES TO CERTAIN WARDS OF THE CITY OF URBANA, ILLINOIS, HERETOFORE ADOPTED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, the 17th day of November, 1958.

WHEREAS, various tracts of real estate have been annexed to the City of Urbana, Illinois, resulting in an increased number of potential voters in said City, who reside in areas which have not heretofore been included within any of the seven authorized wards of said City.

AND WHEREAS, tracts of real estate have been annexed to said City since the adoption of an Ordinance changing the boundaries of wards within the City of Urbana, Illinois, and adding certain territories to certain wards of the City of Urbana, Illinois, adopted by the City Council of said City of the 17th day of November, 1958, resulting in increased number of potential voters in said City, who reside in areas which heretofore have not been included within any of the seven authorized wards of said City.

AND WHEREAS, it appears to the City Council of said City, that in order to comply with statutory requirements that the population of all wards shall be as compact and contiguous territory as practicable, it is necessary and desirable to change the boundaries of the 3rd ward as heretofore bounded and to add such recently annexed territory contiguous to said ward:

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Urbana, Illinois, that the areas annexed to said City since said Ordinance, adopted by the City Council of said City on the 17th day of November, 1958, be added to the area of the 3rd Ward of said City, and that the territory of the 3rd Ward be and include the real estate bounded as follows:

3rd Ward. Commencing at the intersection of the middle of Springfield Avenue and the east line of Wright Street, at the southwest corner of the southeast quarter of Section 7, thence north to the middle of University Avenue, thence east to middle of Wright Street, thence north to the north line of Dunbar Court extended west, thence east to the north east corner of Dunbar Court, thence south to the north boundary of Seminary Addition,

thence east to the middle of Goodwin Avenue, thence north 620 feet, thence east 291.36 feet, thence north 325 feet to the south line of the Northern Illinois Water Service Company land, thence east 371.21 feet, thence south 776.19 feet, thence east 654.92 feet, to the middle of Lincoln Avenue, thence south to the middle of Springfield Avenue, thence west to the place of beginning.

BE IT FURTHER ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:


The City Clerk of said City of Urbana, Illinois, is hereby authorized and directed to cause to be printed a sufficient number of maps of the various wards as created and changed and as now exist, so that it will be convenient for the electors of the City of Urbana to ascertain their voting rights in connection with the municipal elections to be hereafter conducted.

BE IT FURTHER ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:


That all the wards of said City, as established by the Ordinance adopted November 17, 1958, but with the Third Ward as hereby increased and as now exists with the adoption of this amending Ordinance, establishes each of said wards and the boundaries of them as election districts, wards and municipal precincts for said City and the City Elections, and at the time of the elections, all qualified voters who have resided within the respective wards the necessary time, and at least 30 days prior to any municipal election in said municipality, will be entitled to vote at such elections.

This Ordinance shall be in full force and effect on and after its passage, adoption and approval as required by law.
