

AN ORDINANCE providing for calling a Special Election for the purpose of submitting to the voters of the City of Urbana, Champaign County, Illinois, the question of issuing \$2,275,000 Storm Sewer Bonds.

* * * * *

WHEREAS, the City Council of the City of Urbana, Champaign County, Illinois, has heretofore determined and does hereby determine that it is necessary and in the interests of public health and safety that the existing storm drainage system of said City be improved and extended by the construction of a series of interceptors and collection sewers, including outlets therefor, said improvements to consist of approximately 21,000 feet of interceptor storm water sewers in Southeast Urbana, ranging in diameter from 84 inches to 18 inches, approximately 14,000 feet of collector storm water sewers, and an outfall sewer in the University Downs Area of said City, ranging in diameter from 84 inches to 18 inches, the construction of two main interceptor storm water sewers in Northwest Urbana of approximately 10,000 feet, ranging in diameter from 54 inches to 18 inches, the construction of interceptors in the North Urbana Area of approximately 5,200 feet, ranging in diameter from 54 inches to 15 inches, together with other improvements and appurtenances necessary to make such improvements and extensions an integral part of the storm drainage system of said City, and all in accordance with the engineering report therefor heretofore approved by this City Council and now on file in the office of the City Clerk for public inspection; and

WHEREAS, it is hereby estimated and determined that it will cost not less than \$2,275,000 to make such improvements and extensions; and

WHEREAS, funds are not available for the purpose of making such improvements and extensions, and for the purpose of paying the cost thereof it will be necessary to borrow money and in evidence thereof issue bonds of said City; and

WHEREAS, before said bonds can be issued for the purpose of constructing said improvements and extensions to the storm drainage system of said City it will be necessary that the proposition to issue such bonds be submitted to the electors of said City at an election called and held for that purpose, and approved by a majority of the electors voting on said proposition at said election, and it is deemed advisable and in the interests of said City that said proposition be submitted to the electors of said City;

NOW, THEREFORE, Be It Ordained by the City Council of the City of Urbana, Champaign County, Illinois, as follows:

Section 1. That it is hereby determined to be in the interests of public health and safety of the City of Urbana, and its inhabitants, that improvements and extensions be made to the storm drainage system of said City, as hereinabove described in the preamble of this ordinance, and that it will be necessary that the City borrow money and in evidence thereof issue bonds of said City.

Section 2. That there be borrowed for and on behalf of said City the sum of \$2,275,000 for the purpose of paying the cost of constructing improvements and extensions to the storm drainage system of said City, and that to evidence said loan negotiable bonds of said City be issued; that said bonds be designated "Storm Sewer Bonds", be numbered from 1 to 2275, inclusive, be of the denomination of \$1,000 each, and mature serially \$90,000 on December 1 of each of the years 1960 to 1963, inclusive, \$105,000 on December 1 of each of the years 1964 to 1967, inclusive, \$120,000 on December 1 of each of the years 1968 to 1971, inclusive, \$140,000 on December 1 of each of the years 1972 to 1975, inclusive, \$155,000 on December 1 of each of the years 1976 and 1977, and \$145,000 on December 1, 1978, and bear interest at the rate of not to exceed four percent (4%) per annum, payable semi-annually.

Section 3. That the question of issuing said \$2,275,000 Storm Sewer Bonds of said City, as hereinabove described in Section 2 hereof, be submitted to the legal voters of said City at a special election which is hereby called to be held in and for said City on the 7th day of April, 1959 (being the same day and date as the General Municipal Election), between the hours of 6:00 o'clock A.M. and 6:00 o'clock P.M. on said day.

Section 4. That said election shall be held in the respective wards of said City heretofore established as election precincts for all regular elections of said City, and the polling place for each of said wards shall be as follows:

That notice of said election shall be given by publication in the Champaign-Urbana Courier, a newspaper published and of general circulation in said City, not more than thirty days nor less than fifteen days prior to the date set for said election, and that said notice shall be in substantially the following form:

(being the same day and date as the General Municipal Election), a special
election will be held in and for the City of Urbana, Champaign County, Illi-
nois, at which time there will be submitted to the electors of said City
the following question:

Shall bonds in the amount of \$2,275,000 be issued by the
City of Urbana, Champaign County, Illinois, for the purpose
of improving and extending the storm water drainage system
in and for said City, with all necessary connections and
outlets, said bonds to mature serially \$90,000 on December 1
of each of the years 1960 to 1963, inclusive, \$105,000 on
December 1 of each of the years 1964 to 1967, inclusive,
\$120,000 on December 1 of each of the years 1968 to 1971,
inclusive, \$140,000 on December 1 of each of the years 1972
to 1975, inclusive, \$155,000 on December 1 of each of the
years 1976 and 1977, and \$145,000 on December 1, 1978, and
bear interest at the rate of not to exceed four percent
(4%) per annum, payable semi-annually?

That said election shall be held in the several wards of said City
