AN ORDINANCE FOR THE CONSTRUCTION OF CERTAIN SIDEWALKS WITHIN THE CITY OF URBANA, ILLINOIS.

BE IT ORDAINED by the City Council of the City of Urbana, Illinois:

SECTION 1. That concrete sidewalks shall be constructed in the City of Urbana, Illinois, at the following locations, to-wit: on the south side of Western Avenue from Gregory Avenue to Lincoln Avenue; and, on the east side of North Coler Avenue in front of lot 6 of Busey's Subdivision of lot E, and part of Lot B of a subdivision of the southwest quarter of Section eight (8), Township Nineteen (19) North Range Nine (9) East of the Third Principal Meridian, otherwise described as, lot 6 at the address of 610 North Coler Avenue; and, on the west side of North Orchard Street in front of lots 7, 8 and 9 of said subdivision, and otherwise described as lots 7, 8 and 9 with addresses of 609, 607 and 605 North Orchard Street.

SECTION 2. All owners of lots, blocks, tracts, or parcels of land, herein described are hereby required to construct a sidewalk in front of their respective, lots, blocks, tracts and parcels of land in accordance with specifications of Section 30.27 to 30.40 both inclusive, of the Code of the City of Urbana, Illinois of 1954, of a minimum thickness of four inches, with proper grade, materials, methods, joints and finish, within thirty (30) days after the mailing of a notice of the passage of this ordinance, and all as provided in the Ordinances of the City of Urbana, Illinois.

SECTION 3. The City Engineer is hereby authorized and directed to mail such notices to all of the owners of such lots, blocks, tracts or parcels of land, upon the adoption and approval of this ordinance. Such notice shall be addressed to the respective parties shown by the Champaign County, Illinois, Collector, who have paid the general real estate taxes for the last prior revenue year on the respective lots, blocks, tracts or parcels of land.

SECTION 4. In the event the owner or owners of any of the lots, blocks, tracts or parcels of land aforesaid, shall default in the construction of said sidewalks, the City of Urbana may furnish material and construct such sidewalks in accordance with this ordinance

and the ordinances made and provided for the same, or may enter into a contract for the furnishing of materials and construction of such sidewalks in such manner.

SECTION 5. It shall be the duty of the Special Collector to collect the special tax and the warrants, by mail, and written notice to each of the respective owners of such lots, blocks, tracts, or parcels of land having last paid the general real estate taxes for the last prior revenue year as shown by the records of the Champaign County, Illinois, Collector, in accordance with the tax list in the possession of the special tax collector stating that such tax list is in the possession of the said special tax collector for collection of the proper sums.

SECTION 6. The aforementioned sidewalks shall be constructed of portland cement concrete mixed in the proportions and constructed in the manner and in the proportions specified in Sections 30.27 to 30.46 both inclusive, of the Code of the City of Urbana, Illinois of 1954.
