AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA, ILLINOIS.

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that certain real estate owned by School District Number 116 in the County of Champaign and State of Illinois, is situated in unincorporated territory adjacent to the City of Urbana, a Municipal Corporation, and the Board of Education of said School District adopted a resolution on the 17th day of July, 1961, recommending the annexation of the following described real estate by the City of Urbana, Illinois. Said resolution was certified to the City of Urbana, by the Secretary of the Board of Education and a copy of the certified resolution was transmitted to the corporate authorities of said City of Urbana, on the 21st day of July, 1961.

The said real estate is the site commonly known as the Yankee Ridge School site, which is contiguous to the City of Urbana, Illinois, and it appears desirable to the School District and said City that said tract be annexed to the said City, and said real estate is more particularly described as follows:

Commencing at the Northwest corner of the Southwest Quarter of Section Twenty-one (21), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian; thence South Zero (0) degrees Fifty-eight (58) minutes East along the West line of Section Twenty-one (21) One Hundred Seventy-five (175) feet; thence North Eighty-nine (89) degrees Forty-one (41) minutes East One Hundred Eighty (180) feet to a true point of beginning; thence South Zero (0) degrees Fifty-eight (58) minutes East Eight Hundred Eighty-two and Eighty-four Hundredths (882.84) feet; thence North Eighty-nine (89) degrees Thirty-two (32) minutes East Seven Hundred Twenty-two and Thirty-four Hundredths (722.34) feet; thence North Zero (0) degrees Fifty-three (53) minutes West Eight Hundred Eighty and Seventy-five Hundredths (880.75) feet; thence South Eighty-nine (89) degrees Forty-one (41) minutes West Seven Hundred Twenty-three and Seventy-three Hundredths (723.73) feet to the point of beginning, in Champaign County, Illinois.

WHEREAS, at least two-thirds of the aldermen are of the opinion that it would be for the best interests of the City of Urbana, Illinois, that said territory be annexed to and made a part of the City of Urbana.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS.


That said described territory, be the same and is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territory within the corporate limits of said City.

The City Clerk of the City of Urbana, Illinois, shall record with the Recorder of Deeds of the County of Champaign, Illinois, a copy of this ordinance, together with an accurate map of the annexed territory.

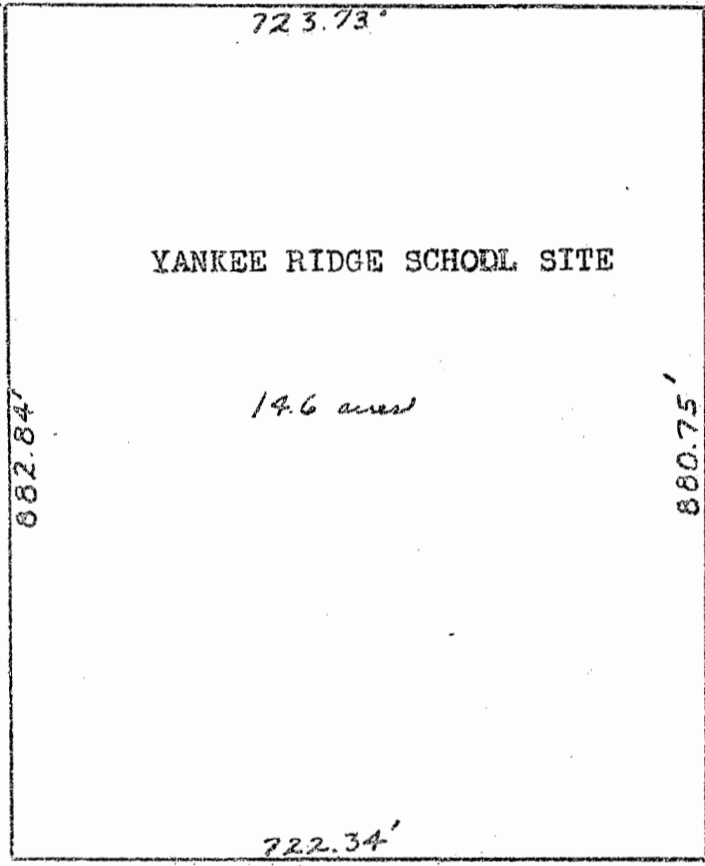


