AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that petitions were filed with the City Clerk of the City of Urbana, Illinois, on the 15th day of January, 1962, requesting the annexation of the territories hereinafter described, which said petitions were signed under oath by all of the owners of record of real estate and all of the electors residing in said territories, and,

WHEREAS, at least two-thirds of the aldermen are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territories be annexed to and made a part of the City Limits of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS.


SECTION I. That the territories described as follows, to-wit:

- Lot 1005, First Plat, in Country Squire Estates,
 - Lot 1009, First Plat, in Country Squire Estates,
 - Lot 1053, Second Plat, in Country Squire Estates,
 - Lot 1056, Second Plat, in Country Squire Estates,
 - Lot 1062, Second Plat, in Country Squire Estates,
 - Lot 1070, Second Plat, in Country Squire Estates,
 - Lot 1072, Second Plat, in Country Squire Estates,
- all situated in the County of Champaign, and State of Illinois,


be, and the same are hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territories within the corporate limits of said City.

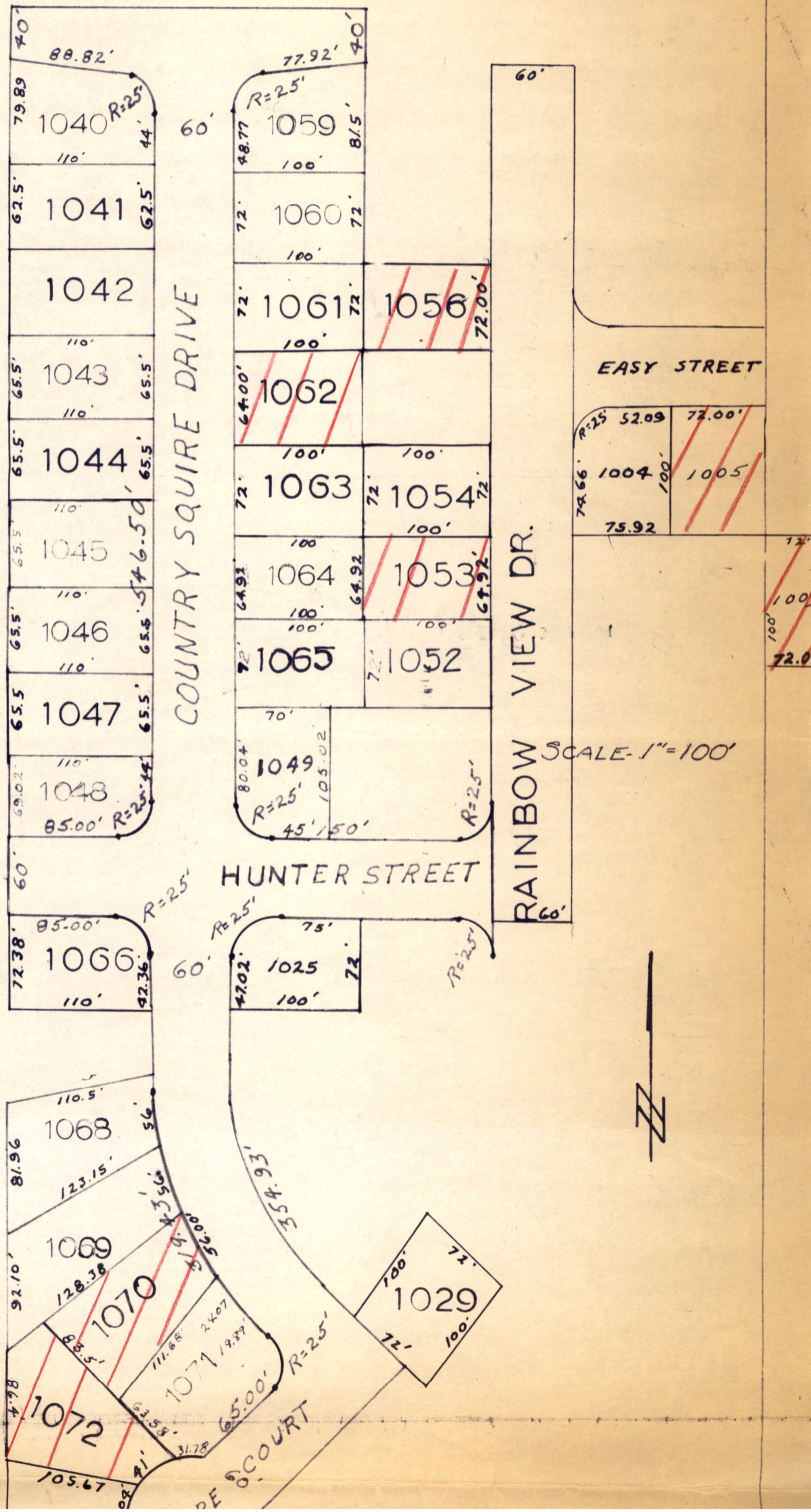

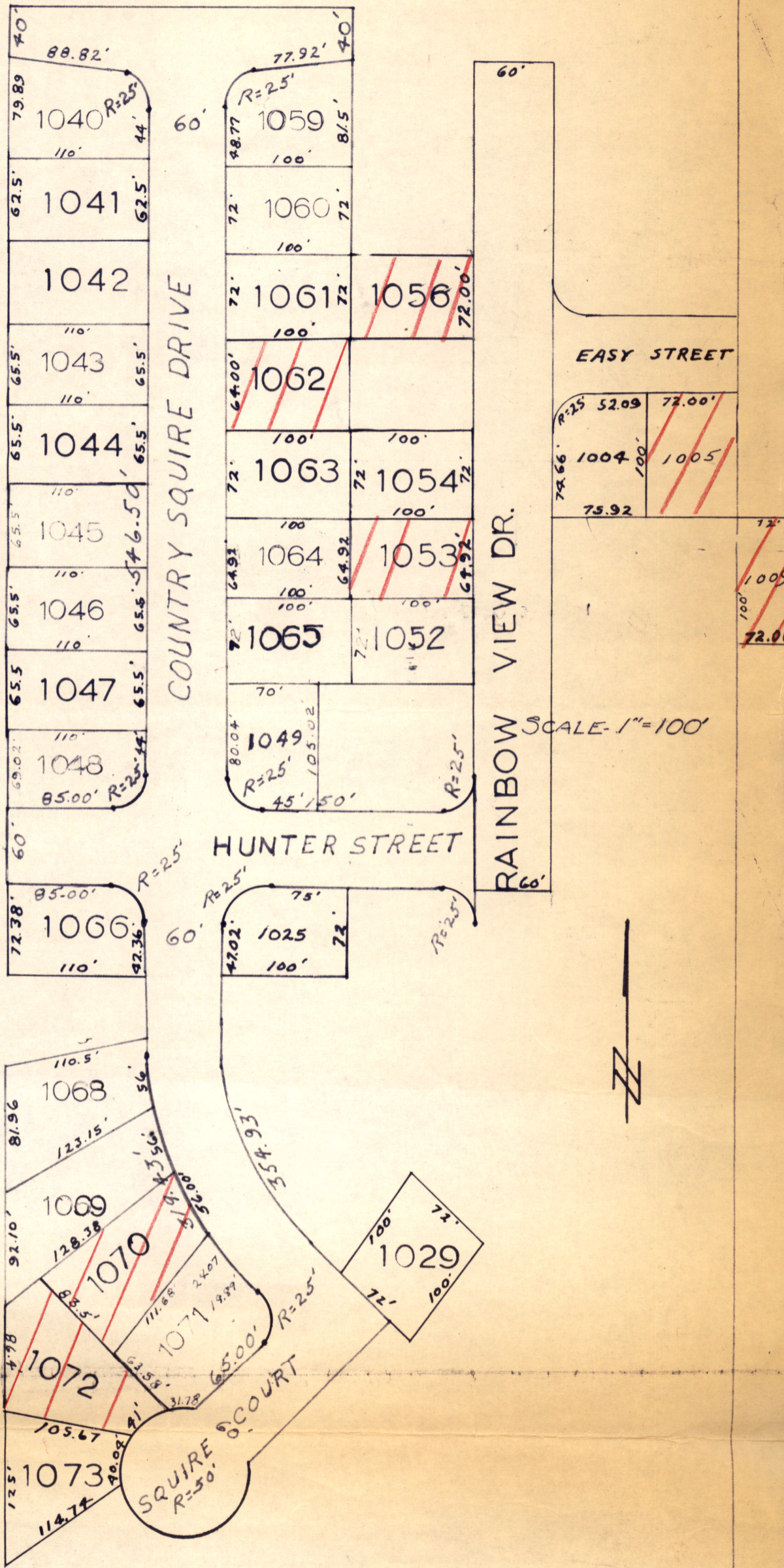
