BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, TLLINOIS:

Section 1. That a census be taken in the City of Urbana, Illinois, for the purpose of ascertaining the population in territory annexed to the City of Urbana, Illinois, during the period \_\_\_\_\_\_\_ 1960 , thru \_\_\_\_\_\_ March, 1962, described in the following ordinances:

Ordinance adopted March 7, 1960, annexing certain territory to the City of Urbana, Illinois, described as Sunnycrest, Inc., First, Second and Fifth Subdivisions.

Ordinance adopted March 7, 1960, annexing certain territory to the City of Urbana, Illinois, described as Sunnycrest, Inc., Sixth Subdivision.

Ordinance adopted April 30, 1960, annexing certain territory to the City of Urbana, Illinois, described in said ordinance.

Section III. After said census is taken, the same shall be subscribed and sworn to by the taker or takers as being true and correct and shall be filed with the City Clerk.

Section IV. The Compensation of said census takers shall be as subsequently determined by the City Council.
