

AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that the unincorporated territory hereinafter described, contains less than sixty (60) acres and is wholly bounded by the municipality of the City of Urbana, Illinois, a municipal corporation, and,

WHEREAS, at least two-thirds of the aldermen of said City are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed and made a part of the City Limits of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION I. That the territory described and bounded as follows, to-wit:

Commencing on the south section line of Section 16 of Township 19 North in Range 9 East of the Third Principal Meridian in Champaign County, Illinois, at the southwest corner of Lot Five (5) in Block 16 of Champaign-Urbana Amvets Subdivision; thence northerly along the west lines of Lots 5, 4, 3, 2, and 1, of said Block 16 to the north corner of said Lot 1; thence west along the south lines of Lots 1, 2, and 7 of Block 15 of said subdivision to the southwest corner of said Lot 7 and west to the east line of Philo Road; thence south along the east line of Philo Road to the south line of said Section 16; thence easterly along the south line of said Section 16 to the southwest corner of said Lot 5, the point of beginning;

Situated in the County of Champaign, and State of Illinois;

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territory within the corporate limits of said City.

SECTION II. The City Clerk of the City of Urbana, Illinois, shall record with the Recorder of Deeds of the County of Champaign, Illinois, a copy of this ordinance, together with an accurate map of the annexed territory.

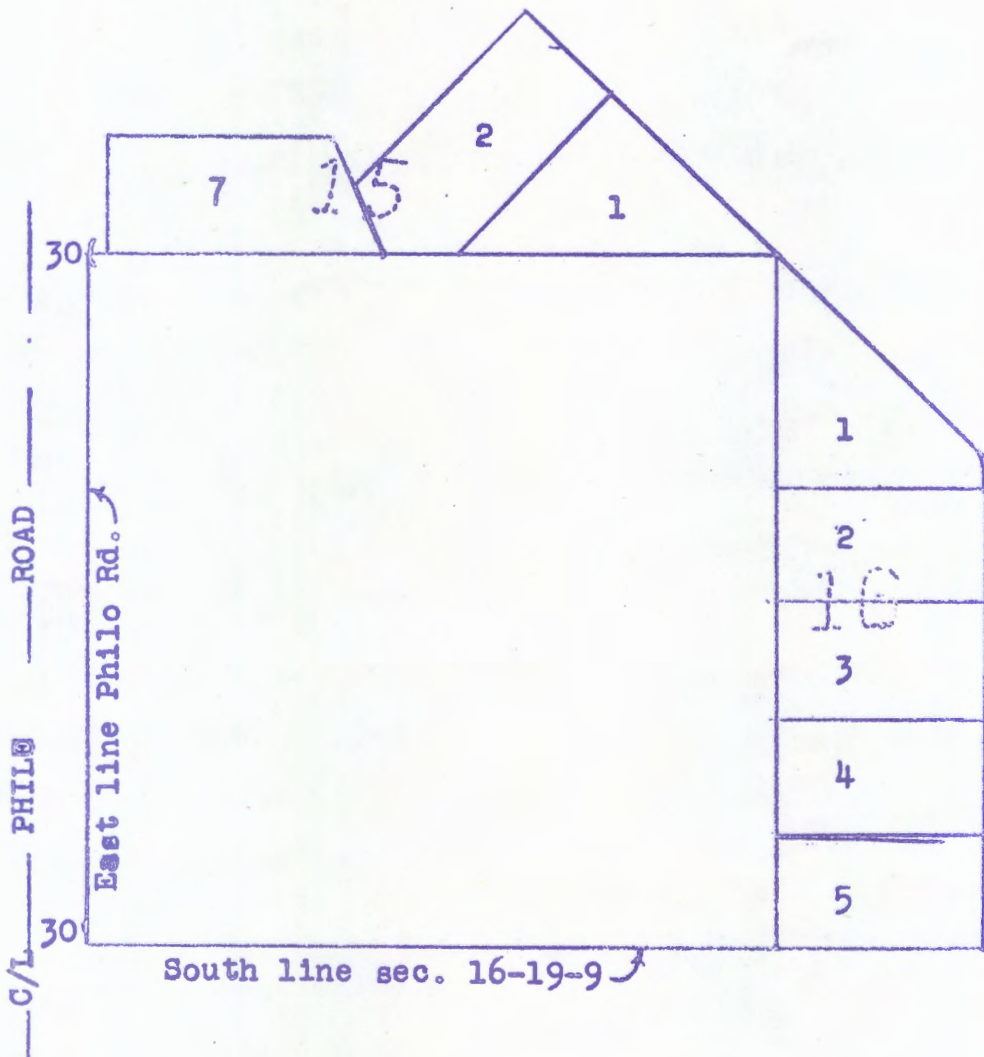
