

AN ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the City Clerk of the City of Urbana, Illinois on the 4th day of September, A.D. 1963, requesting the annexation of the territory hereinafter described, which said petition was signed under oath by all of the owners of record of real estate and <sup>there being no electors</sup> ~~all of the electors~~ residing in said territory, and,

WHEREAS, at least two-thirds of the alderman are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois that said territory be annexed to and made a part of the City Limits of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS.

SECTION I. That the territory described as follows to-wit:

Beginning at a point 1,335.45 feet North of the Southwest corner of the Southeast quarter of Section 21, Township 19 North, Range 9 East of the Third Principal Meridian, said point being on the West line of the Southeast quarter of said Section 21, thence East, 430.30 feet; thence North and parallel with said West quarter-section line, 655.80 feet; thence West, 430.30 feet to the West line; thence South on the West line of the Southeast quarter of said Section 21, 655.80 feet; to the place of beginning, said tract containing 6.478 acres, more or less, being a part of the Southeast quarter of Section 21, Township 19 North, Range 9 East of the Third Principal Meridian;

Situated in the Champaign County and the State of Illinois.



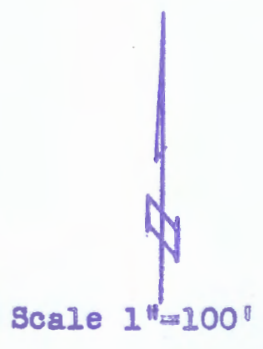
