AN ORDINANCE FOR THE CONSTRUCTION OF CERTAIN SIDEWALKS WITHIN THE CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:
SECTION 1, THAT CONCRETE SIDEWALKS SHALL BE CONSTRUCTED IN THE
CITY OF URBANA, ILLINOIS, AT THE FOLLOWING LOCATIONS, TO-WIT:

On the east side of Broadway Avenue in the City of Urbana, Illinois, from Water Street northward to a line 31 feet south of the south rail which now exists on the Wabash Railroad right-of-way thereat.

SECTION 2. All owners of the lots, blocks, tracts or parcels of land touching the line of the proposed sidewalks are hereby required to construct a sidewalk in front of and touching upon their respective lots, blocks, tracts or parcels of land in accordance with the specifications of Sections 30.27 to 30.40 of the Code of the City of Urbana, Illinois, of 1954, within 30 days after the mailing of a notice of the passage of this ordinance.

The City Engineer is hereby authorized and directed to mail such notices to all of the owners of such lots, blocks, tracts or parcels of land immediately upon the adoption and approval of this ordinance. Such notice shall be addressed to the party who paid the general taxes on the lots, blocks, tracts or parcels of land.

SECTION 3. In case the owner or owners of any lots, blocks, tracts or parcles of land as aforesaid shall default in constructing such sidewalks, the City of Urbana may furnish the material and construct such sidewalks in accordance with this ordinance or may enter into a contract for the furnishing of materials and construction of such sidewalks.

SECTION 4. It shall be the duty of the special collector to collect the warrants by mailing a written notice to the address of the party who last paid the taxes on the lots, blocks, tracts or parcels of land in said tax list stating that said tax list is in the possession of said tax collector for collection.

SECTION 5. The aforementioned sidewalk shall be constructed of Portland Cement Concrete mixed in the proportions and constructed in the manner and in the proportions specified in Sections 30.27 to 30.46

of the Code of the City of Urbana, Illinois, of 1954, and of the dimensions, location, grade and proportions as given by the City Engineer, of approximately the same width as the sidewalk which there exists.

FILED in the Office of the City Clerk for public inspection this 27th day of September, 1963.

Said City is to bear 50 per cent of the costs of the new sidewalk, and the frontage owners are to bear 50 per cent of such costs by special taxation, or by full payment.
