

AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the City Clerk of the City of Urbana, Illinois on the 3rd day of February, A.D. 1964, requesting the annexation of the territory hereinafter described, which said petition was signed under oath by all of the owners of record of real estate and all of the electors residing in said territory, and,

WHEREAS, at least two-thirds of the alderman are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois that said territory be annexed to and made a part of the City Limits of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS.

SECTION I. That the territory described as follows to-wit:

Commencing at a point 174.16 feet North of the SW Corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 7, Twp. 19 North, Range 9 East of the 3rd P.M. in Champaign County, Illinois, thence North 262.20 feet, thence East 315.63 feet, thence South 131.08 feet, thence East 316.22 feet, to the West line of Lincoln Ave., thence South along the West line of Lincoln Ave., 131.07 feet to a point which is located 174.72 feet North of the SE Corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 7, thence west 632.45 feet to the place of beginning, containing three acres, more or less, all situated in the County of Champaign and State of Illinois,

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territory within the corporate limits of said City.

SECTION II. The City Clerk of the City of Urbana, Illinois, shall record with the Recorder of Deeds of the County of Champaign, Illinois, a copy of this ordinance, together with an accurate map of the annexed territory.

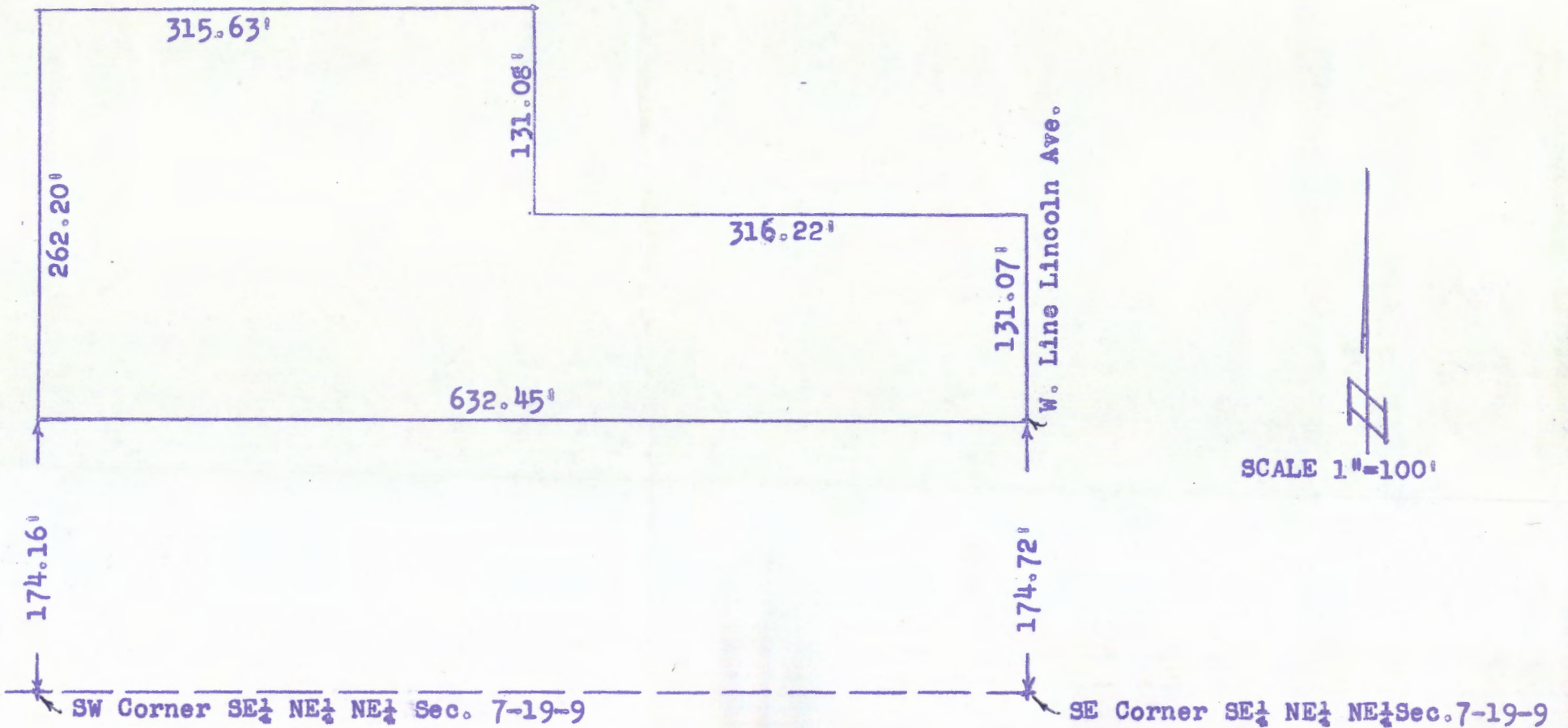
