

AN ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the City Clerk of the City of Urbana, Illinois on the 1st day of April, A.D. 1964, requesting the annexation of the territory hereinafter described, which said petition was signed under oath by all of the owners of record of real estate and all of the electors residing in said territory, and,

WHEREAS, at least two-thirds of the alderman are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois that said territory be annexed to and made a part of the City Limits of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS.

SECTION I. That the territory described as follows to-wit:


South Three (3) Acres of the following tract:

The North Six Hundred Sixty-five (665) feet of the West Three Hundred Ninety Three and 2/100 (393.02) feet of the Northwest Quarter of the Southeast Quarter of Section Twenty-one, Township Nineteen North, Range Nine East of the Third Principal Meridian, containing Six (6) acres, more or less, all located in Champaign County, Illinois;

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territory within the corporate limits of said City.



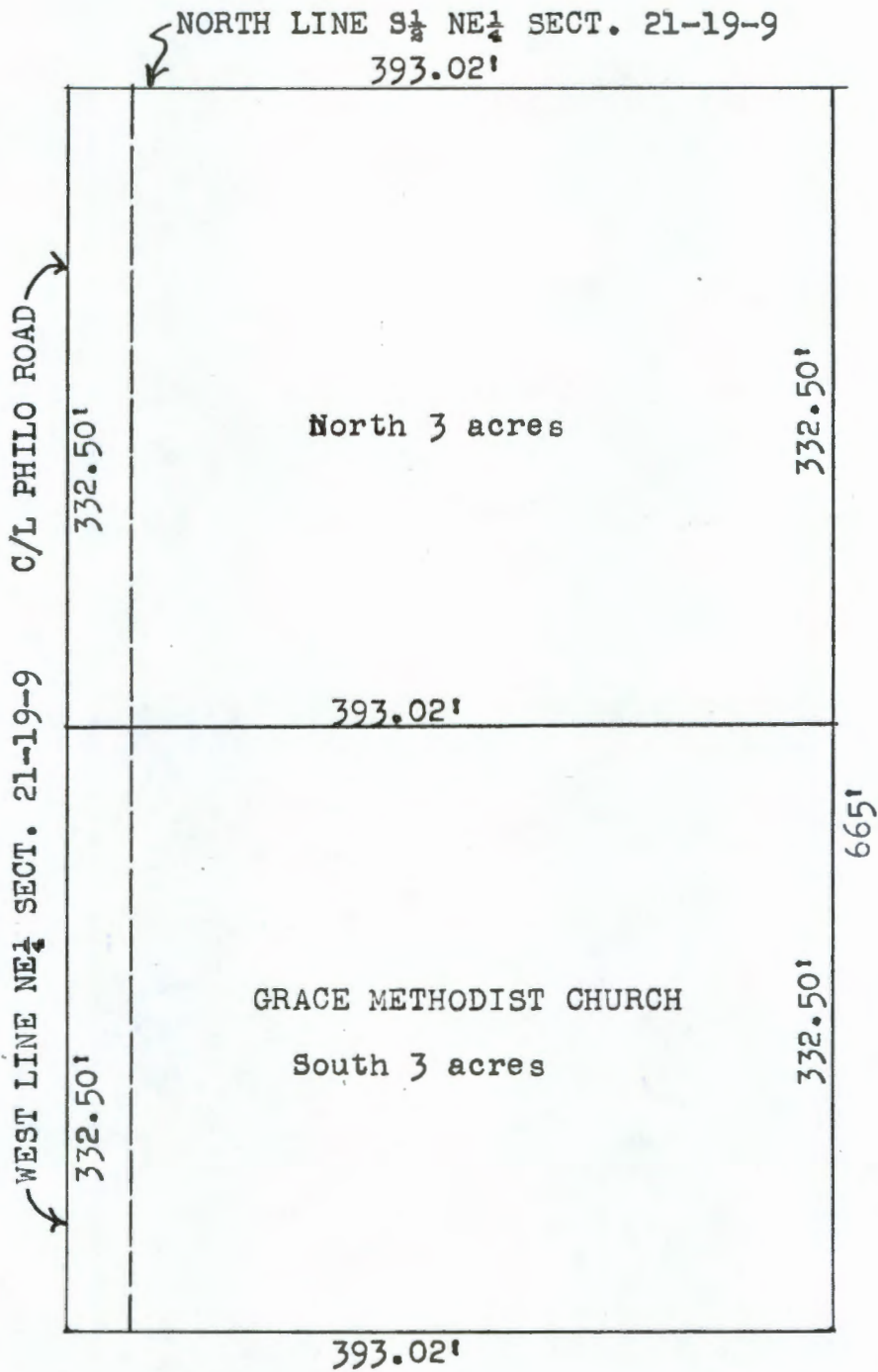
