AN ORDINANCE OF AMENDMENT TO AN ORDINANCE  
AMENDING AN ORDINANCE REGULATING THE SALE AT  
RETAIL OF ALCOHOLIC LIQUORS WITHIN THE CITY OF URBANA,  
ILLINOIS, ADOPTED JUNE 6, 1955, AND TO AMEND  
THE BOUNDARIES OF THE LIQUOR ZONE IN SAID CITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

That Section 11 of "An Ordinance Regulating the Sale at Retail of Alcoholic Liquors Within the City of Urbana, Illinois", adopted May 17, 1954, and amended by "An Ordinance Amending an Ordinance Regulating the Sale at Retail of Alcoholic Liquors Within the City of Urbana, Illinois", adopted June 6, 1955, be further amended by the City Council of said City as follows:

Section 11 of said ordinance adopted May 17, 1954, and amended by another ordinance adopted June 6, 1955, is herewith amended to provide as follows:

SECTION 11. (Restricted Areas.) It is hereby determined that the following described portions of this City are predominantly residential in character:


All of the area comprising the corporate limits of the City of Urbana, except that portion within the following boundary lines:

A line beginning at the center of the intersection of Bennett Avenue and Elm Street and extending thence North along the center of Bennett Avenue to the center line of Main Street; thence East along the center line of Main Street to the center line of Vine Street; thence North along the center line of Vine Street to the center of the Boneyard Ditch; thence in an Easterly direction along the center line of the Boneyard Ditch a distance of Three Hundred Twenty-Five Feet (325'); thence North to the center line of University Avenue; thence in a Westerly direction along the center line of University Avenue to a point located in the center line of University Avenue located One Hundred Fifty Feet (150') East of the East line of Cunningham Avenue measured from the intersection of Cunningham Avenue and University Avenue; thence in a Northeasterly direction on a line which is parallel to and One Hundred Fifty feet (150') East of the East line of Cunningham Avenue to a point One Hundred Twenty-One and Five Tenths feet (121.5') South of the South line of Crystal Lake Drive; thence West to the West line of Cunningham Avenue; thence in a Southwesterly direction along the West line of Cunningham Avenue to a point One Hundred Fifty-Eight and Sixty-Five Hundredths feet (158.65') South of the South line of Crystal Lake Drive; thence West One Hundred Fifty feet (150'); thence in a Southwesterly direction on a line which is parallel to and One Hundred Fifty feet (150') West of the West line of Cunningham Avenue to the center line of University Avenue; thence West along the center line of University Avenue to the center line of Broadway; thence South along the center line of Broadway to the South line of


the Wabash Railroad right-of-way; thence Westerly along and on the South side of said right-of-way of said railroad to a point due North of the center line of Cedar Street; thence running South to a point due East of the center line of Locust Street extended; thence West along the center line of Locust Street extended and along the center line of Locust Street to the center line of Central Avenue; thence South along the center line of Central Avenue to the center line of Main Street; thence in a Southeasterly direction along the center line of Main Street to a point due North of the center line of Cedar Street; thence South to the center line of Cedar Street and along the same to the center line of Elm Street; thence East on the center line of Elm Street to the center line of Race Street; thence South on the center line of Race Street to the center line of Green Street; thence East on the center line of Green Street, and vacated Green Street to the center line of vacated Broadway Street; thence South on the center line of vacated Broadway Street to the North line of High Street; thence West on the North line of High Street to a point 103 feet East of the center line of vacated Crane Alley; thence North on a line parallel with the center line of said vacated alley 108 feet; thence East on a line parallel with the North line of High Street to the center line of vacated Broadway Street; thence North on the center line of vacated Broadway Street and Broadway Street to the center line of Elm Street; thence East on the center line of Elm Street to the point of beginning.

It shall be unlawful to sell or offer for sale at retail any alcoholic liquors other than beer within any such residential portion of the City. Beer may be sold in such residential portions to be consumed on the premises provided that the owners of at least two-thirds of the frontage feet along the street and streets adjacent to such place of business for which a license is sought and a distance of 200 feet in each direction from such place of business along both sides of such adjacent street or streets, and including also the owner or owners of the frontage feet on any street not adjacent to such place of business but lying within a distance of 200 feet in any direction from such proposed place of business, shall file with the Mayor their written consent to the use of such place for the sale of beer therein to be consumed on said premises. Provided, however, that such petition shall not be required for a place of business now established pursuant to a prior petition filed with the Mayor.
