ORDINANCE IN REGARD TO VEHICLE
PARKING, SIGN REQUIREMENTS, AND ENFORCEMENT
ON STREETS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

That the City Council authorizes the Police and Traffic Committee of the Council and the Urbana Police Department and the Street Department of said City to place "No Parking of Motor Vehicles" signs on certain streets in said City and enforce the provisions and the requirements of the signs as follows:

Elm Street from Cedar Street to Busey Avenue;
High Street from Orchard Street to Busey Avenue;
Illinois Street from Orchard Street to Lincoln Avenue;
California Street from Orchard Street to Lincoln Avenue;
Oregon Street from Orchard Street to Lincoln Avenue;
Nevada Street from Orchard Street to Lincoln Avenue;
Washington Street from Orchard Street to Busey Avenue;
Iowa Street from Orchard Street to Lincoln Avenue;
Ohio Street from Orchard Street to Lincoln Avenue.

Such signs placed on the north side of the several locations shall be worded in substance, "No Parking This Side, Monday, Tuesday, and Wednesday"; and such signs placed on the south side of the several locations shall be worded in substance, "No Parking This Side, Thursday, Friday, Saturday, and Sunday".

Orchard Street from Indiana Avenue to Washington Street;
Orchard Street from Illinois Street to Elm Street;
Busey Avenue from Indiana Avenue to Elm Street;
Coler Avenue from Washington Street to Elm Street.

Such latter signs shall be placed on the east side of such latter named streets and shall be worded in substance, "No Parking This Side, Monday, Tuesday, and Wednesday"; and such signs shall be placed on the west side of said latter named streets and shall be worded in substance, "No Parking This Side, Thursday, Friday, Saturday, and Sunday".


These provisions shall prevail except that on California Street from Coler Avenue to Busey Avenue, and on Elm Street from Race Street to Busey Avenue, motor vehicle parking shall be allowed on both sides of these segments of streets on Sunday only.

The Street Department is authorized to erect and maintain such signs at such locations. The Police and Traffic Committee is

authorized to administer such regulations, and the Police Department is authorized to enforce the provisions, sign requirements, and such regulations.


Enforcement shall be in accordance with the signs, and said committee and said departments are authorized to discontinue alternate no parking as previously authorized by ordinance of the City Council adopted November 16, 1964.
