

AN ORDINANCE FOR LOCATION OF
FIRE HYDRANTS

WHEREAS, the Chief of the Fire Department of the City of Urbana, Illinois, the Fire Marshall, recommends to the City Council that fire hydrants be located at the following locations, and,

WHEREAS, it appears to be for the best interests of the people of the City of Urbana, Illinois, for public safety and fire protection to have such fire hydrants so located, and,

WHEREAS, there is a necessity for the location of fire hydrants at the following specified locations;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that fire hydrants be located in the City of Urbana, Illinois, at the following locations:

- At 1309 North Lincoln Avenue;
- At 1212 North Goodwin;
- Sunnycrest Court West between lots 224 and 225;
- Burkwood Court West between lots 291 and 292;
- Northwest corner of Sunnycrest Court East and Anderson Street;
- Burkwood Court East at Southwest Corner of lot 257;
- Sunnycrest Drive between lots 72 and 73;
- Harding Drive between lots 614 and 615;
- Brighton Drive between lots 688 and 689;
- Brighton Drive between lots 676 and 677;
- Southwest corner of Harding Drive and Cottage Grove;
- Northeast corner of Mitchem and Cottage Grove;
- Mitchem Drive at northwest corner of lot 662.

BE IT FURTHER ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that the City Clerk of said City is hereby directed to send a certified copy of this ordinance to the Northern Illinois Water Corporation.


