

AN ORDINANCE PROVIDING FOR THE TAKING OF A  
CENSUS OF TERRITORY ANNEXED TO THE CITY OF  
URBANA, ILLINOIS, DURING THE PERIOD  
MARCH 1962 THRU DECEMBER 1965

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That a census be taken by the City of Urbana, Illinois, for the purpose of ascertaining the population in territory annexed to the City of Urbana, Illinois, during the period March 1962, thru December 1965 described in the following ordinances:

Ordinance adopted May 23, 1962, annexing certain territory to the City of Urbana, Illinois, described as Lot 1051 of Country Squire Estates II.

Ordinance adopted June 4, 1962, annexing certain territory to the City of Urbana, Illinois, described as Lots 1014 and 1028 of Country Squire Estates I, and Lot 1055 of Country Squire Estates II.

Ordinance adopted August 6, 1962, annexing certain territory to the City of Urbana, Illinois, described as Lots 1007, 1008, 1010, 1011, 1015, 1021, 1024, 1026 of Country Squire Estates I, and Lots 1055 of Country Squire Estates II.

Ordinance adopted September 4, 1962, annexing certain territory to the City of Urbana, Illinois, described as Lots 1021 and 1023 of Country Squire Estates II.

Ordinance adopted September 4, 1962, annexing certain territory to the City of Urbana, Illinois, described as Lots 1051 and 1067 of Country Squire Estates II.

Ordinance adopted December 27, 1962, annexing certain territory to the City of Urbana, Illinois, described as Lot 92 of University Downs Third Addition.

Ordinance adopted January 21, 1963, annexing certain territory to the City of Urbana, Illinois, described as Lot 257 of Sunnycrest Inc., 11th Subdivision.

Ordinance adopted January 21, 1963, annexing certain territory to the City of Urbana, Illinois, described as Lot 1016 of Country Squire Estates II.

Ordinance adopted February 18, 1963, annexing certain territory to the City of Urbana, Illinois, described as Lots 25 thru 34 of Dr. Ellis 2nd Subdivision.

Ordinance adopted March 18, 1963, annexing certain territory to the City of Urbana, Illinois, described as Lots 1022 and 1027 of Country Squire Estates I.

Ordinance adopted June 17, 1963, annexing certain territory to the City of Urbana, Illinois, described as Manis Ridge 3rd Subdivision except Lots 28, 29, 42, 43, 55, 59 and 62 therein, Manis Ridge 4th Subdivision, and East 713 feet of South  $\frac{1}{2}$  of Northwest  $\frac{1}{4}$  Section 21-19-9 (Manis Ridge 6th Subdivision).

Ordinance adopted July 1, 1963, annexing certain territory to the City of Urbana, Illinois, described as Lots 28, 29, 42, 43, 55, 59 and 62 of Manis Ridge 3rd Subdivision.

Ordinance adopted October 7, 1963, annexing certain territory to the City of Urbana, Illinois, described as Lot 1118 of Country Squire Estates III.

Ordinance adopted November 4, 1963, annexing certain territory to the City of Urbana, Illinois, described as Ennis Ridge 7th Subdivision.

Ordinance adopted February 8, 1964, annexing certain territory to the City of Urbana, Illinois, described as commencing at a point 174.44 feet North and 33 feet West of the NE corner of the NW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 7-19-9, thence West 621.92 feet, thence South 209.44 feet, thence East 186.32 feet, thence South 100 feet, thence East 435.6 feet, thence North 309.44 feet to the point beginning.

Ordinance adopted February 17, 1964, annexing certain territory to the City of Urbana, Illinois, described as Lot 70 of Sunnycrest Inc. 10th Subdivision.

Ordinance adopted March 16, 1964, annexing certain territory to the City of Urbana, Illinois, described as Ennis Ridge 8th Subdivision.

Ordinance adopted March 16, 1964, annexing certain territory to the City of Urbana, Illinois, described as the North 661.75 feet of the West 394.95 feet of the South  $\frac{1}{2}$  of the NE $\frac{1}{4}$  Section 21-19-9, except the South 3 Acres.

Ordinance adopted June 1, 1964, annexing certain territory to the City of Urbana, Illinois, described as Lot 72 of Sunnycrest Inc. Tenth Subdivision.

Ordinance adopted December 7, 1964, annexing certain territory to the City of Urbana, Illinois, described as Lot 260 of Sunnycrest Inc. 11th Subdivision.

Ordinance adopted January 18, 1965, annexing certain territory to the City of Urbana, Illinois, described as Lot 298 of Sunnycrest Inc. 12th subdivision.

Ordinance adopted February 1, 1965, annexing certain territory to the City of Urbana, Illinois, described as the West 80 feet of Lot 76 of Sunnycrest Inc. 10th Subdivision.

Ordinance adopted February 1, 1965, annexing certain territory to the City of Urbana, Illinois, described as Lot 1032 and that part of Lot 1031 lying southeasterly of a line running from the Northeast Corner of Lot 1031 to a point on the Northerly Line of Country Squire Drive, 2.75 feet Northwesterly from the Southeast Corner of Lot 1031 of Country Squire Estates I and Lot 1036 of Country Squire Estates I.

Ordinance adopted February 15, 1965, annexing certain territory to the City of Urbana, Illinois, described as Lot 264 of Sunnycrest Inc. 11th Subdivision.

Ordinance adopted March 1, 1965, annexing certain territory to the City of Urbana, Illinois, described as Lot 1031 of Country Squire Estates I.

Ordinance Adopted June 7, 1965, annexing certain territory to the City of Urbana, Illinois, described as Ennis Ridge 9th Subdivision.

Ordinance adopted September 7, 1965, annexing certain territory to the City of Urbana, Illinois, described as Lot 1131 of Country Squire Estates III.

Ordinance adopted September 30, 1965, annexing certain territory to the City of Urbana, Illinois, described as Lot 360 of Sunnycrest Inc. 11th Subdivision.

Ordinance adopted September 30, 1965, annexing certain territory to the City of Urbana, Illinois, described as Lot 71 of Sunnycrest Inc. 10th Subdivision.

Ordinance adopted October 4, 1965, annexing certain territory to the City of Urbana, Illinois, described as commencing at a point 375.33 feet South of the NW Corner of NE $\frac{1}{4}$  NE $\frac{1}{4}$  Section 7-19-9, thence Easterly 291.36 feet to a point 375.35 feet South of the North Line of said Section 7, thence South and parallel with the center line of Goodwin Ave. a distance of 250 feet, thence Westerly 291.36 feet to the center line of Goodwin Ave., thence North 250 feet to the point of beginning.

Ordinance adopted October 4, 1965, annexing certain territory to the City of Urbana, Illinois, described as commencing at a point 248 feet West of the NE Corner of the SE $\frac{1}{4}$  NE $\frac{1}{4}$  NE $\frac{1}{4}$  Section 7-19-9, thence West to the NW Corner of said SE $\frac{1}{4}$  NE $\frac{1}{4}$  NE $\frac{1}{4}$  of said Section 7, thence South 330.09 feet more or less to a point which is 436.36 feet North of the SW Corner of said SE $\frac{1}{4}$  NE $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 7, thence East to a point which is 100 feet West of the East line of the NE $\frac{1}{4}$  of said Section 7, thence North 330.09 feet to a point 100 feet South of the North Line of the SE $\frac{1}{4}$  NE $\frac{1}{4}$  NE $\frac{1}{4}$  of said Section 7, thence West 148 feet, thence North 103 feet to the point of beginning.

Ordinance adopted December 6, 1965, annexing certain territory to the City of Urbana, Illinois, described as Lots 28, 30, 46, 47, 48, 51, 52, 53, 54, 117 and 119 of Lincoln wood Subdivision.

Ordinance adopted December 6, 1965, annexing certain territory to the City of Urbana, Illinois, described as Ennis Ridge 10th Subdivision.

Ordinance adopted December 30, 1965, annexing certain territory to the City of Urbana, Illinois, described as Lots 3 thru 20 (except Lot 4) of University Downs 1st Addition, Lots 21 thru 31 of University Downs 2nd Addition, Lots 40, 41, 42, 49 thru 77 of University Downs 3rd Addition, Lots 91 and 121 of University Downs 4th Addition.

Section II: That census takers or takers shall be named by the Mayor and the City Council of said City for the purpose of ascertaining the exact information as to the number of inhabitants in the annexed territory.

Section III: After said census is taken, the same shall be subscribed and sworn to by the taker or takers as being true and correct and shall be filed with the City Clerk.

Section IV: The compensation of said census takers shall be as subsequently determined by the City Council.
