AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that:

Scottswood Drive from the South Line of Main Street to the South line of Lot 4 extended, in Scottswood Sub-Division located in the East Half of the Southwest Quarter of Section 15, Township 19 North, Range 9 East, of the Third Principal Meridian, situated in the County of Champaign, and the State of Illinois;

is contiguous to the City of Urbana, Illinois, and is dedicated and used for street and highway purposes, in accordance with the laws and statutes of the State of Illinois and under the jurisdiction of the Township of Urbana Highway Department, and not within any other municipality, and,

WHEREAS, at least two-thirds of the aldermen are of the opinion that it would be for the best interests of the people of Urbana, Illinois, that said territory be annexed to and made a part of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION I. That the territory, a portion of Scottswood Drive, as described aforesaid, be and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territory within the corporate limits of said City.

SECTION II. The City Clerk of the City of Urbana, Illinois, shall record with the Recorder of Deeds of the County of Champaign, Illinois, a copy of this ordinance, together with an accurate map of the annexed territory.


