Holmes Street between Lots 814 and 815 8. Southwest Corner of Holmes Street and Vine Street 9. Pell Circle between Lots 830 and 831 10. Boudreau Circle between Lots 835 and 824 11. Grange Circle between Lots 822 and 840 12. Northeast corner of Silver Court East 13. Brighton Drive between Lots 688 and 689 14. Harding Drive between Lots 614 and 615 15. Colorado Avenue between Lots 554 and 555 16. Southeast corner of Silver Street and Cottage Grove Avenue 17. Southeast corner of Silver Street and Fletcher Street 18. Mitchem Drive between Lots 661 and 662
