

AN ORDINANCE DECLARING THE NEED AND CONVENIENCE  
 OF THE CITY OF URBANA, ILLINOIS, TO USE AND OCCUPY,  
 FOR STREET AND SIDEWALK PURPOSES, CERTAIN REAL  
 ESTATE HELD BY THE BOARD OF EDUCATION OF SCHOOL  
 DISTRICT NUMBER 116, COUNTY OF CHAMPAIGN AND STATE  
 OF ILLINOIS

WHEREAS, SCHOOL DISTRICT NUMBER 116, COUNTY OF CHAMPAIGN AND STATE  
 OF ILLINOIS is the owner of the premises described as:

A tract of land being a part of Lot Twenty-One (21)  
 of Col. M. W. Busey's Heirs Addition to the Town (now  
 City) of Urbana, County of Champaign and State of Illinois,  
 located and described as follows:

Beginning at the Northeast corner of said Lot Twenty-  
 One (21), said corner being the intersection of the South  
 line of Clark Street with the West line of Lincoln Avenue  
 as now located; thence in a Southerly direction along  
 the East line of said Lot Twenty-One (21) a distance of  
 Two Hundred Eighty and Five-Tenths (280.5) feet, more or  
 less, to the Southeast corner of said Lot Twenty-One (21);  
 thence in a Westerly direction along the South line of said  
 Lot Twenty-One (21), a distance of Fourteen (14) feet;  
 thence in a Northeasterly direction to a point Thirteen  
 and One-Tenth (13.1) feet North and Six (6) feet West  
 of the said Southeast corner of said Lot Twenty-One (21);  
 thence in a Northerly direction on a line parallel to  
 and Six (6) feet West of the said East line of said Lot  
 Twenty-One (21), a distance of Two Hundred Sixty-Seven  
 and Four-Tenths (267.4) feet, more or less, to the North  
 line of said Lot Twenty-One (21); thence in an Easterly  
 direction, a distance of Six (6) feet to the point of  
 beginning, the area of said tract being One Thousand  
 Seven Hundred Thirty-Five and Four Tenths (1735.4) square  
 feet, more or less; all situated in Lot Twenty-One (21)  
 of Col. M.W. Busey's Heirs Addition to the Town (now City)  
 of Urbana, Champaign County, and the State of Illinois.

WHEREAS, the City of Urbana, Champaign County, Illinois is about to  
 improve and widen Lincoln Avenue, a public thoroughfare abutting and ad-  
 joining the above described property on the East and,


WHEREAS, it is required in the interest of public convenience and

 in the interest of the public and the City of Urbana, in Champaign County,  
 Illinois to use, occupy and improve the premises described as:


A tract of land being a part of Lot Twenty-One (21) of Col. M. W. Busey's Heirs Addition to the Town (now City) of Urbana, County of Champaign and State of Illinois, located and described as follows:

Beginning at the Northeast corner of said Lot Twenty-One (21), said corner being the intersection of the South line of Clark Street with the West line of Lincoln Avenue as now located; thence in a Southerly direction along the East line of said Lot Twenty-One (21) a distance of Two Hundred Eighty and Five-Tenths (280.5) feet, more or less, to the Southeast corner of said Lot Twenty-One (21); thence in a Westerly direction along the South line of said Lot Twenty-One (21), a distance of Fourteen (14) feet; thence in a Northeasterly direction to a point Thirteen and One-Tenth (13.1) feet North and Six (6) feet West of the said Southeast corner of said Lot Twenty-One (21); thence in a Northerly direction on a line parallel to and Six (6) feet West of the said East line of said Lot Twenty-One (21), a distance of Two Hundred Sixty-Seven and Four-Tenths (267.4) feet, more or less, to the North line of said Lot Twenty-One (21); thence in an Easterly direction, a distance of Six (6) feet to the point of beginning, the area of said tract being One Thousand Seven Hundred Thirty-Five and Four Tenths (1735.4) square feet, more or less; all situated in Lot Twenty-One (21) of Col. M.W. Busey's Heirs Addition to the Town (now City) of Urbana, Champaign County, and the State of Illinois.
