

AN ORDINANCE FIXING COMPENSATION OF OFFICERS AND EMPLOYEES, OF THE CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION I. That beginning May 1, 1967, the monthly salaries (or hourly wages) of the following named officers and employees of the City of Urbana, Illinois, shall be as follows:

Table listing salaries for various city positions: Mayor (\$400.00), Mayor as President of the Board of Local Improvements (100.00), Local Liquor Control Commissioner (100.00), City Clerk and Collector (600.00), City Treasurer (125.00), City Attorney and Corporation Counsel (600.00 - 785.00), Commissioner of Public Works and Building Official (800.00 - 985.00), City Engineer (700.00 - 850.00), Director of Public Safety (735.00 - 985.00), Fire Department Administrator (50.00), Dog Control Officer (180.00), Part-time Clerk and Typist (1.75 - 2.00 per hr.), Draftsman and Assistant (1.80 - 2.25 per hr.), Parking System Gate Attendant (1.25 - 1.50 per hr.), Public Works Department - Temporary Employees (1.75 per hour).

SECTION II. That beginning May 1, 1967 the monthly salaries of the following employees of the City of Urbana shall be the base salary as listed below plus 2% of said base salary for each two years of continuous city employment completed prior to May 1, 1967; and in conjunction with the Longevity Ordinance to be currently adopted: Assistant City Engineer (\$640.00), Building Inspector (550.00), Plumbing Inspector (500.00)

SECTION III. Local Improvement fees on all projects based upon the actual cost of construction of each project, shall be paid into the General Corporate Fund from said projects in lieu of paying such fees to the Corporation Counsel.


SECTION IV. All engineering fees from Local Improvements shall be paid into the General Corporate Fund. Extra help employed by the City Engineer on Local Improvements projects shall be paid from the General Fund at an hourly rate to be determined by the City Council.

SECTION V. Each member of the Civil Service Commission shall receive \$10.00 per year as payment for his services on the said commission.

SECTION VI. For each regular meeting or special meeting of the City Council attended by him, each Alderman shall receive a compensation of \$15.00.


SECTION VII. All ordinances or parts of ordinances in conflict herewith, are hereby repealed.
