AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA, ILLINOIS

whereas, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the City Clerk of the City of Urbana, Illinois, on the 4th day of December, A.D. 1967, requesting the annexation of the territory hereinafter described, which said petition was signed under oath by all of the owners of record of real estate and all of the electors residing in said territory, and,
