AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that the herein described territory is contiguous to the City of Urbana, Illinois, and is dedicated and used for street purposes under the jurisdiction of the Urbana Township Highway Department, and none of said territory is situated in any incorporated city or village; and,

WHEREAS, said territory is located, bounded and described as follows:

Michigan Avenue between the City limits and the East line of Section 16, Township 19N, Range 9E, of the 3rd Principal Meridian, situated in Champaign County, Illinois.

and; WHEREAS, two-thirds of the aldermen are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the City of Urbana, Illinois, a municipal corporation;

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that said described territory be, and the same is hereby annexed to and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said city be and the same shall be changed so as to include said territory within the corporate limits of said city.

The City Clerk of the City of Urbana, Illinois, after the passage of this ordinance of annexation, shall certify a correct copy of this ordinance, together with an accurate map, and shall file the same with the Recorder of Deeds of Champaign County, Illinois.
