ORDINANCE OF ADOPTION OF THE COMPREHENSIVE PLAN FOR THE CITY OF URBANA, ILLINOIS

WHEREAS the Corporate Authorities of the City of Urbana, Illinois, a municipal corporation, initiated plans and maps and the Comprehensive Plan, by request to the Plan Commission of said City, to prepare an official Comprehensive Plan, and recommend the same to the City Council of the City of Urbana, Illinois; and,

WHEREAS the Plan Commission of said City, for several years, on such request, has considered and developed a Comprehensive Plan, and conducted public hearings on the same, and the last public hearing having been held by the Plan Commission on April 29th, 1968; and,

WHEREAS the Comprehensive Plan, Final Report (Summary Statement), November, 1967, was submitted and is recommended to the City Council, and is so recommended, as modified, for adoption of the City Council of said City; and,

whereas consideration of such plan by the City Council was made on the recommendation of the Plan Commission, submitted and recommended by the Plan Commission to the City Council, as corrected by the Plan Commission Erata dated April 15, 1968; both documents as modified by the staff review of comprehensive plan, dated July 12th, 1968, of the Champaign County Regional Planning Commission to the Urbana City Plan Commission, and to include Map #2 ("Downtown - West Urbana Land Use Study") included in such staff review, and as further modified by the letter of the Urbana Plan Commission to the Urbana City Council this 22nd day of July, 1968, for adoption of the Plan by the Corporate Authorities of said City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that the proposed official comprehensive plan, as modified, be and is hereby adopted as the official Comprehensive Plan for said City.

FURTHER BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that the map entitled "Comprehensive Plan" submitted and recommended with the Comprehensive Plan, including the Plan Commission Erata dated April 15, 1968; both documents, as modified by the staff review of comprehensive plan, dated July 12, 1968, of the Champaign County Regional Planning Commission to the Urbana City Plan Commission on July 12, 1968, and to include Map #2 ("Downtown - West Urbana Land Use Study") included in such staff review, and as further modified by the letter of the Urbana Plan Commission to the Urbana City Council this 22nd day of July, 1968, are a part of the official Comprehensive Plan.

FURTHER BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that notice of the adoption of such Comprehensive Plan, as so modified, be filed promptly with the County Recorder of Deeds of Champaign County, Illinois, together with a certified copy of this ordinance.
