

AN ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed with the City Clerk of the City of Urbana, Illinois, on the 1st day of July A.D., 19 69, requesting the annexation of the territory hereinafter described, which said petition was signed under oath by all of the owners of record of real estate and all of the electors residing in said territory, and,

WHEREAS, <sup>a majority</sup> ~~at least two-thirds~~ of the aldermen are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the City Limits of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS.

SECTION I. That the territory described as follows, to-wit:

Beginning at the Northwest (NW) corner of Lot Forty-eight (48) of Carver Park Addition to the City of Champaign, Illinois, thence West 190 feet to the West line of the Southeast Quarter (SE 1/4) of Section Six (6), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence North along said line 611 feet, thence East 765 feet to the East line of Carver Park Subdivision, extended North, thence South along said extended line, 726 feet to the Northeast (NE) corner of Lot Sixteen (16) of said Subdivision, thence West 450 feet to the Southeast (SE) corner of Lot Forty-eight (48) of said Subdivision, thence North along the East line of said Lot Forty-eight (48) 115 feet, thence West 125 feet along the North line of said Lot Forty-eight (48) to the place of beginning, situated in the County of Champaign and State of Illinois

Said area is located in the Southwest Quarter of the Southeast Quarter of Section 6, Township 19 North, Range 9 East of the Third Principal Meridian, in Champaign County, Illinois, and is north of the Carver Park Addition, and consists of 11.92 acres, more or less, and is owned by Henry Sapoznik, whose address is 222 West Main Street, Urbana, Illinois.

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territory within the corporate limits of said City.

SECTION II. The City Clerk of the City of Urbana, Illinois, shall record with the Recorder of Deeds of the County of Champaign, Illinois, a copy of this ordinance, together with an accurate map of the annexed territory.
