

ORDINANCE NO. 7071-18
ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and,

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that other territory hereinafter described as contiguous to the City of Urbana, Illinois, and is dedicated and used for street purposes in Urbana Township in Champaign County, Illinois, and no part of the same is within any other municipality; and,

WHEREAS, the majority of the Aldermen are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Lot No. 337, Fourteenth Subdivision, Sunnycrest, Inc.,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the territory described as follows, viz:

"Evergreen Court East, a street right-of-way, between the West edge of South Anderson Street to a point described as the West edge of Lot 337, Fourteenth Subdivision, Sunnycrest, Inc."



Section 4. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.





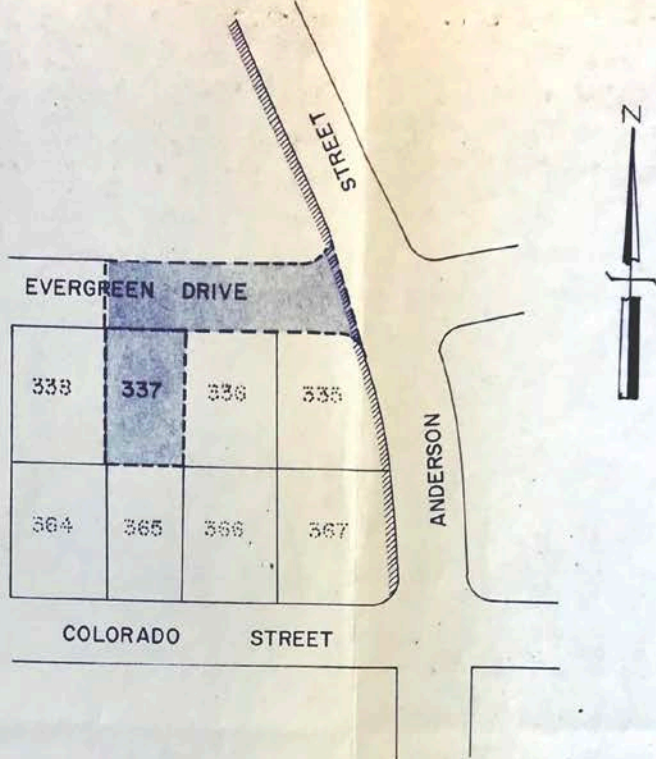
