## ORDINANCE 7071-29

## BE IT ORDAINED BY THE URBANA CITY COUNCIL THAT:

A Person who knowingly hinders, delays, resists or obstructs the performance by one known to the person to be a City Officer, or known to the person to be a person legally authorized by a City Officer, of any authorized act within his official capacity, shall be fined in accordance with Section 1.6 of the City Code; a Person who shall knowingly and willfully neglect or refuse to obey any lawful order or direction of any such City Officer when such person knows the order or direction was issued by one known to him to be a City Officer, shall be fined in accordance with Section 1.6 of the City Code.

Former section 2.16 of the City Code of Urbana is hereby repealed upon the foregoing Section becoming effective.

This Ordinance shall be effective immediately upon its adoption and approval by the Mayor.
