

ORDINANCE NO. 7071-33

AN ORDINANCE TO INCREASE RATES  
OF FIRE PROTECTION TAX

WHEREAS, the City of Urbana levied a tax for Fire Protection purposes in 1966, and

WHEREAS, the rate limitation for the City of Urbana for Fire Protection purposes was less than .30% on the effective date of the Amendatory Act of 1969 to the Fire Protection Tax, Section 11-7-3 of Chapter 24, Illinois Revised Statutes, 1969, and


WHEREAS, the City Council of Urbana deems it advisable for the common good of the City of Urbana to raise the rate limitation for Fire Protection Tax,

BE IT THEREFORE ORDAINED THAT:

1. The rate limit to provide revenue for the purpose of Fire Protection in the City of Urbana shall henceforth be .30% of the value of the taxable property in the City of Urbana.

2. That the City Clerk is directed to forthwith publish Notice of passage of this Ordinance once in a newspaper having general circulation in the City of Urbana and this Ordinance shall not take effect until thirty (30) days after such publication of Notice.
