

ORDINANCE NO. 7071-37

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and,

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that other territory hereinafter described as contiguous to the City of Urbana, Illinois, and is dedicated and used for street purposes in Urbana Township in Champaign County, Illinois, and no part of the same is within any other municipality; and,

WHEREAS, the majority of the Aldermen are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Lots 854 and 855 of Ennis Ridge Eleventh Subdivision in Champaign County, Illinois, as per plat recorded in plat book "S" at page 5 in the Recorder's office of said County,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the territory described as follows, viz:

"McHenry Street, a street right-of-way, between the East line and the West line of Lot 854 of Ennis Ridge Eleventh Subdivision in Champaign County, Illinois, extended South across said street,"


be and the same is hereby annexed to and shall hereafter be a part of the City of Urbana, Illinois, and that the Corporate Limits of said City be, and the same shall be changed to include said territory within the Corporate Limits of the said City.

Section 3. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance, together with an accurate map of the territory hereinabove described, in the Office of the Recorder of Deeds for Champaign County, Illinois.


Section 4. This Ordinance shall be in full force and effect from its passage and recording as provided by law.

ORDINANCE NO. 1041-31

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and,

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that other territory hereinafter described as contiguous to the City of Urbana, Illinois, and is dedicated and used for street purposes in Urbana Township in Champaign County, Illinois, and no part of the same is within any other municipality; and,

WHEREAS, the majority of the Aldermen are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Lots 854 and 855 of Ennis Ridge Eleventh Subdivision in Champaign County, Illinois, as per plat recorded in plat book "S" at page 5 in the Recorder's office of said County,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the territory described as follows, viz:

"McHenry Street, a street right-of-way, between the East line and the West line of Lot 854 of Ennis Ridge Eleventh Subdivision in Champaign County, Illinois, extended South across said street,"

be and the same is hereby annexed to and shall hereafter be a part of the City of Urbana, Illinois, and that the Corporate Limits of said City be, and the same shall be changed to include said territory within the Corporate Limits of the said City.

Section 3. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance, together with an accurate map of the territory hereinabove described, in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 4. This Ordinance shall be in full force and effect from its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 17th day of August, 1970.



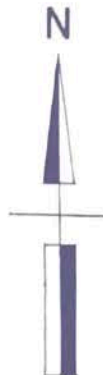

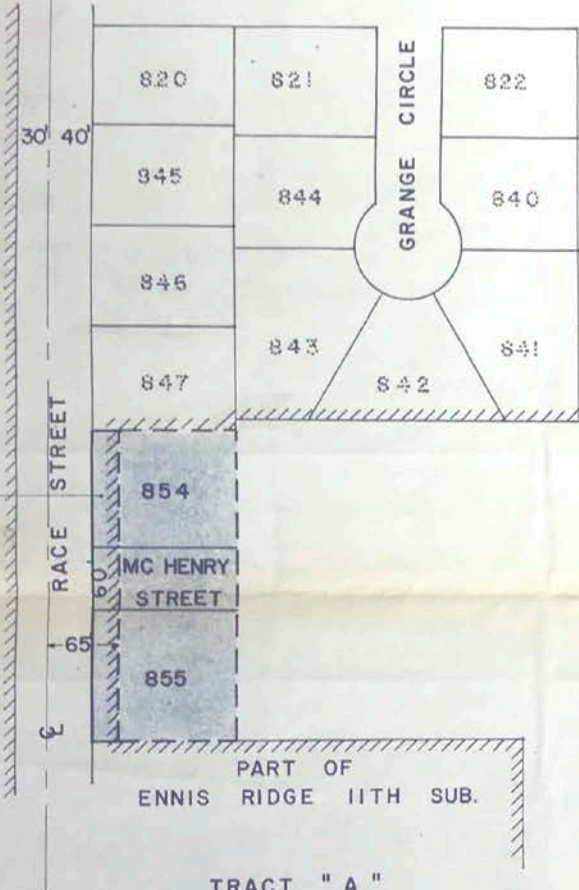
