ORDINANCE ANNEXING CERTAIN TERRITORY

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

WHEREAS, a written Petition, signed by the owners of record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and there being no electors residing thereon; and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF URBANA, ILLINOIS, AS follows:

Section 1. That the following described real estate, viz:

Lot 1123, Country Squire Estates, Third  
Plat, Champaign County, State of Illinois

be and the same is hereby annexed to the City of Urbana, Illinois.




Section 4. This Ordinance shall be in full force and effect from and after its passage and recording as provided by law.
