commonly known as 707 Burkwood, Urbana, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.



Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.





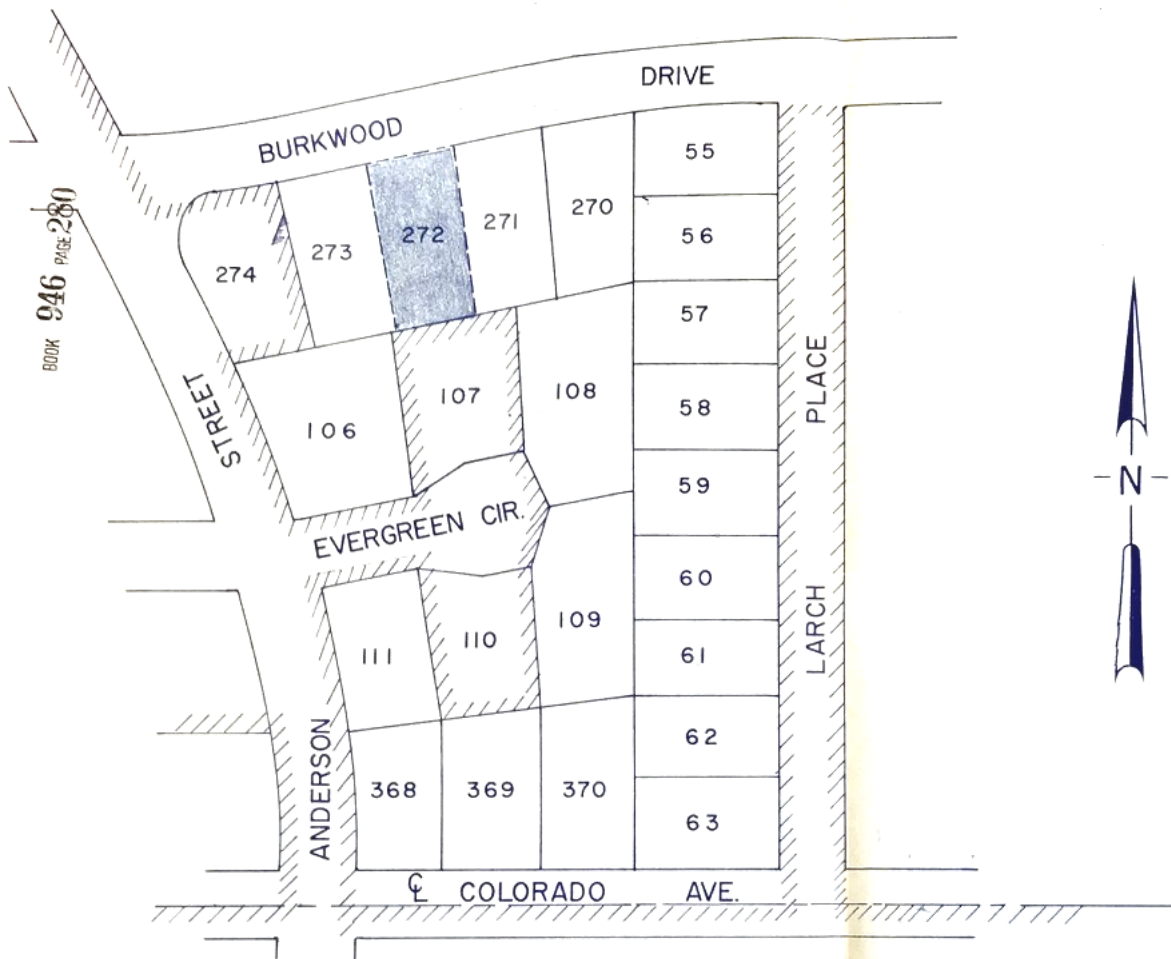
