be and the same is hereby annexed to the City of Urbana, Illinois.

lies between the East line of South Anderson Street and the  
East line of Lot 263 of Sunnycrest 11th Subdivision, extended.

be and the same is hereby annexed to the City of Urbana, Illinois.



Section 4. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.



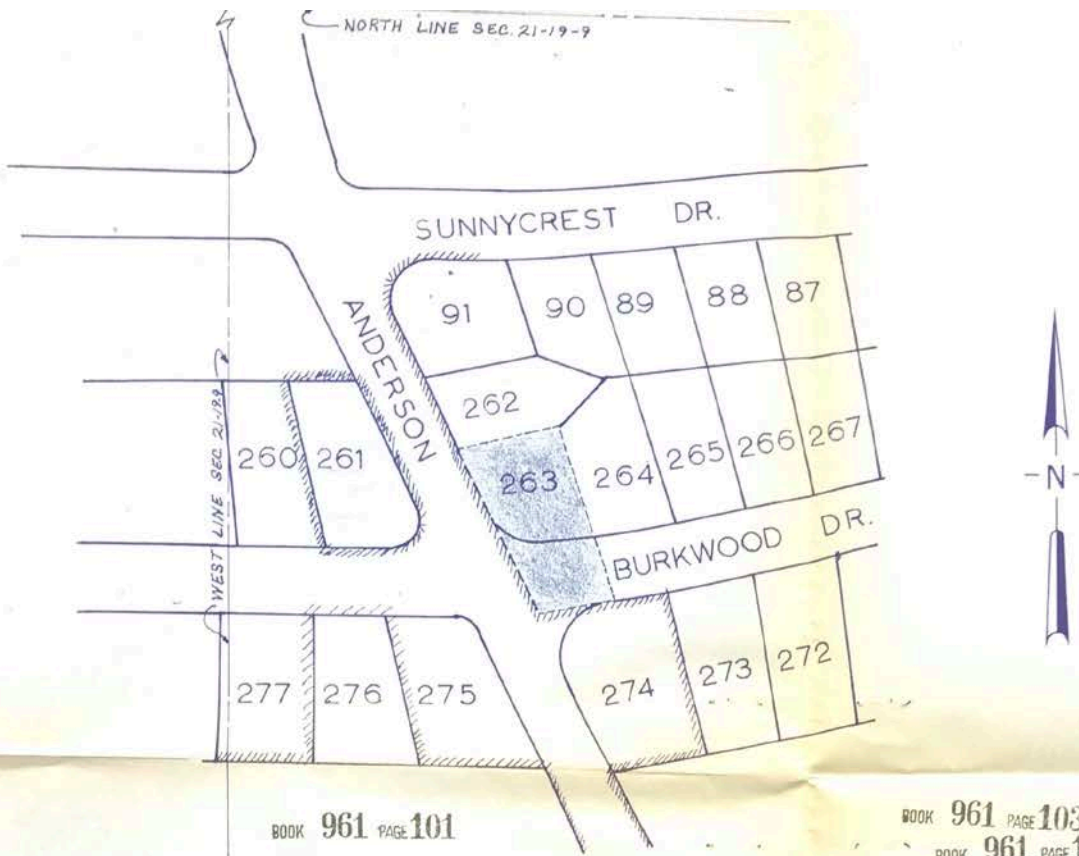
