ORDINANCE ANNEXING CERTAIN TERRITORY

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

TO THE CITY OF URBANA

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Aldermen are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

North, Range 9 East of the Third Principal Meridian, Thence North, along the East line of said Quarter Quarter, 605.33 feet, for a true place of beginning; thence West 40.00 feet; thence North 113.38 feet; thence Southwesterly along a line having an angle to the right from the last described line of 323° 07' 48", 50.00 feet; thence South 73.38 feet; thence West 530.00 feet; thence North 436.70 feet; thence East 600.00 feet to the East line of said Quarter Quarter; thence South 434.67 feet to the place of beginning, all situated in Section 21, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois.
