AN ORDINANCE PROVIDING FOR THE TAKING OF A CENSUS OF TERRITORY ANNEXED TO THE CITY OF URBANA, ILLINOIS, DURING THE PERIOD APRIL 2, 1970 THRU SEPTEMBER 30, 1971

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS: SECTION 1. That a census be taken by the City of Urbana, Illinois, for the purpose of ascertaining the population in territory annexed to the City of Urbana, Illinois, during the period April 2, 1970 thru September 30, 1971, described in the following ordinances:

Ordinance adopted April 5, 1970, annexing certain territory to the City of Urbana, Illinois, described as Lot 282, Sunnycrest 11th Subdivision to the County of Champaign, State of Illinois, commonly known as 505 Burkwood Court East.

Ordinance adopted April **20**, 1970, annexing certain territory to the City of Urbana, Illinois, described as the West half of the South half of the North two-thirds of Lots 6, 7, 10 and 11 of a subdivision of the Northwest Quarter of Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, situated in Champaign County, Illinois, commonly known as 804 Oakland Avenue.

Section 2. That census taker or takers shall be named by the Mayor and approved by the City Council of said City for the purpose of ascertaining the exact information as to the number of inhabitants in the annexed territory.

Section 3. After said census is taken, the same shall be subscribed and sworn to by the taker or takers as being true and correct and shall be filed with the City Clerk.

Section 4. The compensation of said census takers shall be so subsequently determined by the Mayor and approved by the City Council.
