

ORDINANCE NO. 7273-11

AN ORDINANCE PROVIDING FOR THE TAKING OF A CENSUS
OF TERRITORY ANNEXED TO THE CITY OF URBANA, ILLINOIS
DURING THE PERIOD OF SEPTEMBER 20, 1971, THROUGH JUNE 30, 1972

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That a census be taken by the City of Urbana, Illinois, for the purpose of ascertaining the population in territory annexed to the City of Urbana, Illinois, during the period from September 20, 1971, through June 30, 1972, described in the following ordinances:

Ordinance adopted October 4, 1971, annexing certain territory to the City of Urbana, Illinois, described as the South 135 feet of the West 150 feet of the East 183 feet of the Northeast Quarter of the Northeast Quarter of the Northeast Quarter of Section 7, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois, said tract containing 0.46 acres more or less, all situated in Champaign County, Illinois, commonly known as 1405 - 1407 North Lincoln Avenue, Urbana, Illinois.

Ordinance adopted November 15, 1971, annexing certain territory to the City of Urbana, Illinois, described as Lot 385 in Ennis Ridge Sixteenth Subdivision, Lot 384 in Ennis Ridge Sixteenth Subdivision, and all that part of Whitson Circle lying between the South line of Lot 384 extended, to the North line of Lot 385 extended, being a street right-of-way.

Ordinance adopted November 15, 1971, annexing certain territory to the City of Urbana, Illinois, described as Lot 48 in Sunnycrest, Inc. Fourth Subdivision, Champaign County, Illinois, being a part of the North Half of the Northwest Quarter of Section 21, Township 19 North, Range 9 East of the Third Principal Meridian, situated in Champaign County, Illinois, commonly known as 1812 Larch Place, Urbana, Illinois.

Ordinance adopted January 3, 1972, annexing certain territory described as Lot 279 in Sunnycrest, Inc. Eleventh Subdivision to the County of Champaign, State of Illinois, commonly known as 605 Burkwood Court East, Urbana, Illinois.

Ordinance adopted January 17, 1972, annexing certain territory described as Lot 1312 in the Sixth Plat of Country Squire Estates, Champaign County, Illinois, commonly known as 2112 Easy Street, Urbana, Illinois.

Ordinance adopted January 17, 1972, annexing certain territory described as the West 800 feet of the Northwest Quarter of the Northeast Quarter of Section 21, Township 19 North, Range 9 East of the Third Principal Meridian of Champaign County, Illinois; except the North 16 1/2 feet thereof; and also excepting the South 660 feet thereof, commonly known as a vacant tract of land located South and East of the intersection of Philo Road and Florida Avenue, Urbana, Illinois.

Ordinance adopted February 21, 1972, annexing certain territory described as Lot 50, Sunnycrest Fourth Subdivision, commonly known as 1816 Larch Place, Urbana, Illinois.

Ordinance adopted March 20, 1972, annexing certain territory to the City of Urbana, Illinois, described as that part of the West 701.52 feet of the North 412.00 feet of the Northeast Quarter of the Northwest Quarter of Section 21, Township 19 North, Range 9 East of the Third Principal Meridian, except the West 157.00 feet of the North 240.00 feet thereof, which lies East of the East line of Cottage Grove Avenue, containing 5.51 acres more or less; and also Cottage Grove Avenue from the South line of Florida Avenue to the South line of the above said tract, and Sunnycrest Drive from the present City Limits East to the West line of Cottage Grove Avenue, all situated in Champaign County, Illinois, commonly known at 1107, 1201, 1203, and 1209 Florida Avenue Urbana, Illinois.

Ordinance adopted May 1, 1972, annexing certain territory to the City of Urbana, Illinois, described as the East 620 feet of the South 605.33 feet of the Northeast Quarter of the Northwest Quarter of Section 21, Township 19 North, Range 9 East of the Third Principal Meridian, commonly known as Sunnycrest Center, (1807, 1811, 1809, 1813, 1821 Philo Road, and 1402, 1404, 1406 East Colorado Avenue), Urbana, Illinois, and

The South 605.33 feet of the Northeast Quarter of the Northwest Quarter of Section 21, Township 19 North, Range 9 East of the Third Principal Meridian, lying East of Cottage Grove Avenue extended, except the East 620.00 feet thereof, commonly known as the Northeast Corner of Cottage Grove Avenue extended, and

Lot 265 of Sunnycrest Ind., Eleventh Subdivision, commonly known as 706 East Burkwood, Urbana, Illinois, and

Lot 108 of Sunnycrest Inc., Fifteenth Subdivision, commonly known as 706 Evergreen Circle, Urbana, Illinois.

and

Lot 63 of Sunnycrest Inc., Ninth Subdivision, and Lots 363, 365, 367, 369, and 370 of Sunnycrest Inc, Seventeenth Subdivision, commonly known as 804 Colorado Avenue, 705 Evergreen Circle, 608, 612, 616, 704, and 802 Colorado Avenue, Urbana, Illinois.

Ordinance adopted June 19, 1972, annexing certain territory to the City of Urbana, Illinois, described as those lots and tracts not in the City of Urbana, Illinois, on May 11, 1972, which are in the Northeast quarter of the Northeast Quarter of Section 20, and of the North half of the Northwest Quarter of Section 21, all in Township 19 North, Range 9 East of the Third Principal Meridian in Champaign County, Illinois, and the area is bounded by Florida Avenue, Philo Road, Colorado Avenue and Vine Street.

SECTION 2. That census taker or takers shall be named by the Mayor and approved by the City Council of said City for the purpose of ascertaining the exact information as to the number of inhabitants in the annexed territory.

SECTION 3. After said census is taken, the same shall be subscribed and sworn to by the taker or takers as being true and correct and shall be filed with the City Clerk.

SECTION 4. The compensation of said census takers shall be so subsequently determined by the Mayor and approved by the City Council.
